COURSE DESCRIPTION: The Cosmetology program is a 1500-hour program that prepares students for certification and career as a Cosmetologist. The curriculum covers: haircutting and styling techniques, hair restructuring with permanent waves, relaxers and texturizers, application of colors using new techniques, manicuring and nail extensions, facials, make-up application. The State Board of Cosmetology governs the program.

HIGH SCHOOL students attend the Huron Area Technical Center from 8:15 until 11:00 a.m. or from 11:30 a.m. until 2:30 p.m., Monday through Friday, following the school calendar. Students will earn about 2 1/2 hours per day towards the 1500 hour logged instruction requirement. Juniors and Seniors become eligible for the program by completing the HATC enrollment form and submitting it to their home school counselors.

ADULT students attend the Huron Area Technical Center from 8:00 a.m. until 3:30 p.m., earning 7 hours per day, Monday through Friday, towards the 1500 hour logged instruction requirement. Adults become eligible by registering at the Huron Area Technical Center, and are accepted on a first-come first-serve basis as slots become available. Registration is ongoing with official enrollment taking place in August.

PLEASE NOTICE a student is responsible for payment of tuition and all fees listed above at the time of registration.

STATE BOARD EXAM is both a practical (hands-on) and a written examination. Upon completion of the 1500-hour requirement, passing all exams with scores of 85% or above, and successfully completing all the required Minimum Practical and Theory Applications the student will apply to PSI Licensure and Certification for testing. The fee is \$167.00 plus a \$63.00 license fee (The State Board Exam fee and the License fee must be paid using Visa or Master Card *ONLY*).

ATTENDANCE is mandatory for both the high school student and the adult student. Students not attending as required will forfeit their slots in the program. High school students jeopardize their credit with poor attendance. Adult students are required to attend the full day program so as to receive a comprehensive course of study and to enable course completion. Every hour that is missed subjects the Adult student to additional tuition expense.
