



**Parent-Student Contract**

By signing this contract I agree to abide by all of the rules, policies, and procedures set forth by the Cougar Academy and the Ada City School District. I understand that failure to do so may result in loss of privileges or dismissal from the Cougar Academy.

Check all of the following as you read them. By doing this, you are acknowledging you will follow these rules, policies, and procedures:

 $\Box$  I understand I will be required to complete 90% of all activities. This will include attending virtual meetings, answering emails, text messages, or other forms of social media, and answering phone calls. Failure to follow this requirement may result in being dismissed from the program.

 $\Box$  I understand that I am responsible for abiding by rules in the student handbook regarding integrity, discipline, and plagiarism.

 $\Box$  I understand that the curriculum with this program requires a computer and access to the internet and it is my responsibility to make sure I have both.

□ I understand that I must use my Ada City Schools email and I must check it daily.

 $\Box$  I understand the coursework can be as rigorous as the traditional setting and I will meet my assignment calendar for all courses.

 $\Box$  I understand that I will be expected to stay on pace and maintain progress in my online coursework as determined by the due date for each lesson in my content management system. I understand I may be required to attend on-site monitoring if my grade falls below seventy percent or if I fall behind the required pace.

□ I understand that eligibility will be determined each Friday morning and any student failing two weeks in a row will be required to spend a minimum of one full day at the Academy working on coursework. Failure to attend this day may result in removal from the program and that student may be considered truant.

 $\Box$  I understand that there will be frequent communication with the program coordinator and teachers and my parents/guardian may be contacted if my progress requires attention.

□ I understand I am to stay on pace with readings, assignments, labs, quizzes, and tests.

 $\Box$  I understand I am expected to do my own work and can expect to be dismissed from the program if I violate the cheating/plagiarism policy set forth by the district.

 $\Box$  I understand, while using school internet resources, I will be expected to abide by the District Internet Use Agreement.

 $\Box$  I understand that I may be required to take some assessments, including all state tests, at the Academy site. Transportation will be my responsibility.

 $\Box$  I understand that any coursework not completed by the end of the semester will result in an F on my transcript or grade report.

 $\Box$  As a student, I understand that failure to abide by this contract may result in removal from the Cougar Academy program and I will be required to return to On Campus classes.

□ As the parent/guardian, I understand my participation in my child's education will help determine their success. Therefore, I agree to be accessible to the Cougar Academy staff to discuss my child's progress, promote good attendance, and time management.
