### 4-D) Superintendent/Elementary Principal:

### 4-E) Secondary Principal/A.D. Report:

1. Mr. Remboldt updated the board on how the school was addressing student needs during the online learning process. He explained that teachers are checking in with students and contacting parents to address any concerns as the school works as a team in conjunction with parents to continue to uphold excellence in education.

#### 5. UNFINISHED BUSINESS:

- **5-A) Teacher Evaluations:** Teacher evaluations are due by May 15<sup>th</sup> of 2020.
- **5-B) Collaborative bargaining:** Collaborative bargaining will begin the week of April 13<sup>th</sup> with no definitive time set at this time.
- **5-C) Facilities:** Heating system work on the southeast wing was discussed. Shawn Dziuk made a motion, seconded by Marie Bittner to complete the work. Motion unanimously carried.
- 5-D) Committee meeting: Joint co-op meeting is on hold.
- 5-E) Use of cell phones and headphones: Decision was placed on hold.
- **5-F) Opening of tractor bids:** Board president Lisa Gerving reported that she had received three bids on the tractor. Lisa Gerving opened the bids \$3560.00 was the bid from Stacy Geck, \$3570.00 was the bid from Ed Barth, and \$4000.00 from Jerome Schantz. Motion was made by Shawn Dzuik, and seconded by Carrie Gerving to accept the \$4000.00 bid from Jerome Schantz. Motion unanimously carried.

#### 6. NEW BUSINESS:

## 6-A) Staffing Updates:

- 1. Summer School/Summer blast Mr. Barry voiced his intentions to still hold Summer Blast even if it has to be done remotely in an online format.
- 2. Lunches for students started on 3/17/2020. The school will begin providing breakfast/lunch for ages one to eighteen starting on April 20<sup>th</sup>, 2020. This service will be delivered and Mr. Barry will work on any reimbursement paperwork that needs to be completed for this community service.
- 3. Facility staff continues to clean and disinfect the school.
- 4. Teaching staff meetings continue to take place in an online format.
- **6-B) Pre School Program Update:** There are eight students signed up to begin preschool next year. A motion was made to approve the 2020-2021 school year program by Carrie Gerving, seconded by Marie Bittner. Motion unanimously carried.
- **6-C) Designate a Precinct for Election:** This was tabled until after the business manager and superintendent attend a meeting with the North Dakota School Board Association on April 14<sup>th</sup>, 2020. A special meeting will be called to address the election.
- **6-D) Hire election workers for June 9<sup>th</sup>, 2020 Election:** A motion was made by Carrie Gerving, seconded by Marie Bittner for Business manager, Christine Lawson to hire election workers. Motion unanimously carried.
- 6-E) 3 on 3 Basketball Tournament: Cancelled.
- **6-F) Driver's Education:** This item was tabled but will be readdressed following the recommendations of the Governor and North Dakota's Superintendent of Schools.

- **6-G) Collaborative Bargaining Group Meeting Times 2020:** Mr. Barry will contact the committee members the week of April 13<sup>th</sup> to come up with a time and a meeting forum.
- **6-H) Budget Report:** The school will continue to pay its staff including bus drivers. A motion was made by Travis Thomas, and seconded by Matt Miller to approve the paying of coaches. Motion carried. Marie Bittner abstained from voting. The coaches will be expected to make contact with their teams and Mr. Remboldt will help provide the coaching staff with courses that they can take during this time.
- **6-I) Glen Ullin School Parking Lot:** TAND was given permission to park their equipment on the west side of the building. They will leave the parking lot in the same condition or better when they are done using this space.
