"The family wants to ensure that the land that has been in their family for generations, some of it since 1900, is forever shielded from unwanted subdivision and development. The Olsons want the land to continue to provide diverse healthy forests and meadows, provide a haven for wildlife and a source of clean water to Big Bear Creek, Mount Deary Creek and the Potlatch River." The representatives came to inform the school board of the opportunities available to our students to participate in use of the land.

- o Bovill School, Office-Kindergarten section update:

- o SEL Outreach Activity:
