at 4 pm on Thursday, July 22, 2021, virtually through Zoom.*

A virtual meeting was held using Zoom: Becky Cahill, Matt Devino, Amy Dodge, Erin Drislane, and Michael Ellington.

I. Call to Order: The meeting was called to order at 4:16 pm. by Mrs. Drislane.

II. Letters of resignation

III. Hiring

Grade 4 Teacher - Mrs. Drislane recommended to the full Board the hiring of Katherine Stolarcyk as a grade 4 teacher for the 2021-2022 school year at a master's degree step 2 with a salary rate of \$46,837. Mrs. Dodge seconded. Vote: 5-yes Becky Cahill, Matt Devino, Amy Dodge, Erin Drislane, and Michael Ellington.

Counselor - Mrs. Drislane recommended to the full Board the hiring of Marisa Kadar as the school counselor for the 2021-2022 school year at a master's degree step 4 with a salary rate of \$51,265. Mrs. Cahill seconded. Vote: 5-yes Becky Cahill, Matt Devino, Amy Dodge, Erin Drislane, and Michael Ellington.

Custodian - Mrs. Drislane recommended to the full Board the hiring of Katelynn Hoffman as a custodian beginning July 19, 2021, with a salary rate of \$19.54 per hour. Mr. Devino seconded. Vote: 5-yes Becky Cahill, Matt Devino, Amy Dodge, Erin Drislane, and Michael Ellington.

IV. Executive Session for the Purpose of Reviewing the Non-Certified Contract 2021-2024 with Action Anticipated.

Mrs. Drislane invited Dr. Roy and Dr. Fellows into the Executive Session at 4:23.

The Board came back at 7:34 to the original board meeting. Mrs. Drislane recommended to the full Board the approval of the collective bargaining agreement between the North Canaan Board of Education and the North Canaan Elementary School Employees Local 1303-269 of Council 4 AFSCME, AFL-CIO from July 1, 2021, through June 30, 2024, as discussed in executive session. The approval will only be effective upon ratification by the union. Mr. Ellington seconded. Vote: 4-yes Becky Cahill, Amy Dodge, Erin Drislane, and Michael Ellington. 1- abstain Matt Devino.
