**B.** Rainier Cheer Update: Coach Lori and Misty: Request to Board Program background: We support football, but also made history this year, we went to game day: we took 3rd, competed at allstate. Attended 3 virtual competitions, took 1st place in a virtual competition. Nationals happen all over the US and we'd like to go to Anaheim, California. Fully funded by cheer if given the opportunity. We are not asking for money. Over the last 4 years we have deposited over \$60,000 with at least 80 percent from fundraising. We've even paid for some girls' rentals. Estimate is about \$750 per kid, we are thinking more like \$1400 per kid.

#### **Board Comments:**

Girls work hard and they truly are athletes. The expectations are high. Football has traveled, wrestling has traveled.

Where are nationals? How many days will they be gone?

All over, but the closest one is in Anaheim, California, we will be gone for 5 days, competing for 3 days.

This is a great opportunity for the girls and coaches. Great Job, Well worth it.

Blown away by all your work and the standards you hold the team to.

This is one of the strongest programs we have and hope there is a plan for after you ladies (coaches) leave us.

#### C. Facilities Update: Mr. Brown

Thanks to maintenance and custodial. They take on monumental tasks everyday.

- **Custodial:** The team is adapting to new breakfast and lunch models, they are keeping their heads above water. I'm working with different vendors to look at cost savings. I have also started looking at winter projects to get started.
- Maintenance: Working with Tech to get TV's up and we are almost done with the
  high school. We are already addressing issues that came with the fire inspection.
  I have also started looking at areas that were identified to be purged and cleaned
  around the district. I've started a course to become a Certified Pool Operator.
  Working hard to move departments to proactive instead of reactive.
- Facilities Use: Outdoor season is coming to an end and we will be seeing the indoor sports and events starting up.

**Board Comments:** Thanks for the report and great to hear proactive. Thanks for coming tonight. Report appreciated. Mr. Knox is listed as the current lead operator for the water system, but I am trained as well, we need to do paperwork to switch it over.

Our water tower gets inspected around the same time that the city water tower is inspected.

The football lights were needing to be fixed. What issues are there with HB 3294? How are we doing in the locker rooms? HPE Gym? Gym Floor, can't that temporarily be fixed without replacing the whole floor? Do we have updates on resolutions on Pool issues?

Mr. Brown: The football lights had fallen off the radar, thanks for the reminder.

The locker rooms will be worked on this week. The gym, cost and work wise, we need to make sure we have the right plan in place and get it done right.

We have been addressing pool issues, so we will be ready for the swim team.

Outstanding issues are being addressed as quickly as we can.

HB 3294 is ensuring we are providing the products as required by the state.

Regarding HPE gym floor before we button it up again we need to be 100 percent we've got it covered. The problem spot is that whole corner of the gym.
