Bus Rules and Regulations

1. Pupils being transported are under authority of the bus driver.
2. Fighting, wrestling, scuffle or boisterous activity is prohibited on the bus.
3. Pupils shall use the emergency door only as directed by the bus driver or only in case of emergency.
4. Pupils shall be on time for the bus both morning and evening. Pupils need to be at their bus stop at least five minutes prior to pick up, parents with pupils second grade and below must be at the bus stop at least five minutes prior to drop off and must be visible to the bus driver in order for the pupil to be released from the bus.
5. Pupils shall not bring firearms, knives, weapons, or other potentially hazardous material such as matches or other incendiaries and concussion devices on the bus.
6. Pupils shall not bring animals, except approved assistance guide animals on the bus.
7. Pupils shall remain seated while the bus is in motion.
8. Pupils may be assigned seats by the driver.
9. When necessary to cross the road, pupils shall cross in front of the bus or as instructed by the bus driver.
10. Pupils shall not extend their hands, arms, or heads through bus windows.
11. Pupils shall not do any disruptive activity which might cause the driver to stop the bus in order to reestablish order.
12. Pupils shall not possess and /or use tobacco, alcohol or illegal drugs.
13. Pupils shall have written permission to leave the bus other than at home or school. Note must have date, address, name and phone number on it.
14. Pupils shall converse in normal tones; loud or vulgar language is prohibited.
15. Pupils shall not open or close windows without the permission of the bus driver.
16. Pupils shall keep the bus clean and refrain from damaging it.
17. Pupils shall be courteous to the driver, to fellow pupils, and passers-by.
18. Pupils shall not threaten or physically harm the driver or other riders.
19. Pupils shall not carry glass containers or other glass objects on the bus.
20. Pupils shall not approach the bus while the bus is moving.
21. Pupils who refuse to obey promptly the directions of the driver or refuse to obey rules and regulations may forfeit their privilege to ride on the buses.
22. Pupils shall not throw or propel any object(s) while on the bus. (1st infraction of this rule will result in an automatic 3 day suspension from the bus.)

These rules and regulations, if broken are SEVERE violations with severe consequences because of the threat to the safety of others. Severe violations may result in loss of transportation services upon a first infraction.
