**Athletic Committee Report** – Athletic Director, Gary Wilson reported that the spring sports season has begun with JV & Modified Softball, all three levels of baseball, Tennis and Track & Field. Mr. Novotarski asked if Trap Shooting Club has begun. Mr. Wilson said it started last evening with 9 students.

**Buildings & Grounds Committee Report** – Mr. Ovitt said the committee met on March 28<sup>th</sup> and discussed safety issues with the risers at the high school and that a proposal will be forthcoming for purchasing new ones along with a proposal to replace stairs in the auditorium. Mr. Ovitt said they also discussed the need to purchase additional AED's for the district and informed the Board that the fuel tank at the high school needs to be drained and cleaned.

Budget Presentation to BOE. – Michelle Taylor presented the 2023-2024 budget \$23,293,895 an increase of 3.39% with a proposed tax levy increase of 0.9%.

Shannon Fornier asked if ESD would continue next year. Ms. Taylor said the administration will have to discuss that. Mr. Ovitt said that ESD was 100% funded by ESSER monies and it is not included in the budget for next school year.

# 12. STUDENT/PUBLIC COMMENTS

Desiree Morgan – spoke to the Board about her concerns that her special needs child and other special needs children are being discriminated against. Specifically, her child and others were excluded from picture day. She said inappropriate comments about her child's class were made by staff and an aide spoke hatefully about her son. She said her child is being mocked by others and she is demanding change. She believes DEI training is needed and if nothing changes she will take further action.

Ashley Harris – parent – Ashley said she is also a parent of a special needs child and she shares the same concerns along with being short staffed all of the time. She quoted NYS Education laws and said both staff and teacher's behavior is unacceptable. She said the culture needs to change and special needs students need to stop being excluded.

Christi Murray – parent – Christi said her child is a special needs student and she just wants him to be treated normally and doesn't believe it's asking too much.

Bob Duffy – parent – Mr. Duffy spoke to the board about NYS trainings that are happening in our school on Superintendent Conference Days. He believes that the training included speaking to staff about white privilege and he doesn't want that filtering down to our students and thinks it's divisive. He wants social issues to be handled by parents and thinks parents should be made aware of what these trainings are before they happen.

#### 13. ADMINISTRATIVE COMMENTS FOR THE GOOD OF THE ORDER

Mr. Baker wished everyone a nice spring break. He said they had a nice awards ceremony for students and he was slimed today. He thanked the PTSA for all they do.

Mr. Hamm said the 3<sup>rd</sup> quarter has ended and wished everyone a nice spring break.

Mr. Mark – Congratulated all the newly tenured teachers and said that today's student events were on the schools Facebook page.

Mr. Ovitt thanked all the parents who came out tonight and said the Administration is working on the issues they presented. He said there is DEI training on the 28<sup>th</sup> of April and they will be bringing it back to staff. Ms. Morgan said she and others are willing to help because it needs to be addressed. Mr. Ovitt thanked the PTSA for all they do. And said the kids had a great time. He wished everyone a nice spring break. A parent in the audience asked when will they know about the plan to address these issues and staffing. Mr. Ovitt said they will discuss it.
