(500 words or less)	Students had greater access to small group instruction as a direct result of the increase in staffing provided by SIA. Additionally, the curriculum adoption not only provided staff and students with more relevant and rigorous instruction, but also got Rainier School District back on track with ODE's curriculum review/adoption cycle. It has helped restore hope for many that we are addressing the learning needs of our students. Additionally, staff and students have reported higher levels of satisfaction and support because we have a social worker on site to support the SEL needs of our students while providing support to staff.

What adjustments, if any, did you make to your SIA plan as a result of these challenges? (500 words or less)	Our greatest challenge has been to recruit and hire school staff. This resulted in modifying our original grant because we could not fill some positions.
