2021-22 School Overview

The mission of Indian Valley Intermediate School is to provide a safe, caring learning environment that promotes student success in academics and collaboration. Indian Valley Elementary serves grades 6-8 in the Stony Creek Joint Unified School District. Classrooms are combination classes usually with 10 to 12 students per class. The teacher to student ratio is usually 10:1. There is also two para educators assigned to each classroom to support the teacher in addition to providing additional support special education students and general education students for students as needed. Indian Valley Elementary is located in Colusa County and is approximately 20 miles from the districts main campuses located in Elk Creek. Native American students make up the majority of students in the district. The school is in a rural, low income area forty miles from Willows, CA. The goal of Indian Valley is to prepare students for High School by increasing reading, writing and math scores as well as increasing attendance rates.

The school is in process of being updated with new active panes, a new greenhouse for gardening and chicken coup to prepare the way for future FFA participation at the high school Sports is available to students as well in the form of cross country, basketball and volleyball.

2021-22 School Safety Plan

The Stony Creek Joint Unified School District Safety Plan encompasses all school sites overall and contains sections specific to each site. The Safety Plan is reviewed and updated yearly and approved by the Board of Trustees in March. Regular fire drills are held, as well as earthquake and intruder-on-campus drills. These drills are recorded and maintained to document all drills in the district office. The District notification system allows for the capability to respond to an emergency in a rapid, effective manner through e-mail/voice call and text. Through the Catapult system, we are able to summon fire and/or law enforcement immediately, including local first responders who have been trained on the system alongside school personnel. The emergency notification system is sophisticated and has many features, including the ability to determine the location of teachers and students through GPS and an "all call" feature that allows the school to notify and update parents in the event of a school emergency. The ALICE program for campus threats is new to the district as of 2021. The district is pursuing a camera monitoring system for each campus as well.

Professional development was focused on distance learning due to school shutdown in 2019-20. Teachers learned to use Google Classroom and Zoom to conduct lessons. 2021-22 emphasis is on classroom management and instruction (each teacher is reading Tools for Teaching) as well as focus on CAASPP writing and scoring. Para educators are receiving training in reading instruction grades K-8. Trainings are provided to all teachers and support staff throughout the year.
