*Parents will receive progress reports and report card for each nine week period during the school year. Schoolwide assessment results will be provided at the completion of each assessment period (Fall, Winter, Spring).*

- 4. Provide parents reasonable access to staff.**

*Parents are welcome to schedule teacher conferences during teacher planning times and after 2:45 p.m. Parents are also encouraged to contact the school by email or telephone to arrange an appointment to speak with teachers, counselors, and/or administrators as needed.*

- 5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities.**

*Parents are typically able to volunteer for a variety of school functions and activities, both inside and outside the classroom. These opportunities may be held in-person or virtually, depending on the most current guidelines provided by the CDC and ADPH.*

- 6. Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.**

*Jim Pearson Elementary School uses several communication platforms, such as: SchoolCast, Class Dojo, and various social media outlets. Translators are also provided as needed for families who need assistance with communication.*
