## Savoy ISD Student and Parent Chromebook Use Agreement and Incident Cost

In support of our SISD mission statement to provide 21st century learning opportunities by encouraging accountability, equity and quality, students enrolled in 7<sup>th</sup>-12<sup>th</sup> grades will be provided a Chromebook computer for instructional purposes. Your knowledge of the policies described below, as well as your support in implementing these policies, is critically important.

#### Terms

Parents and students must comply at all times with the Savoy ISD Student and Parent Chromebook Use Agreement, Savoy ISD Acceptable Use Policy, Savoy ISD Student Code of Conduct, and Savoy ISD Student Handbook. Any failure to comply may cause the termination of student rights of use immediately.

#### Title

At all times, the legal title to the Chromebook is maintained by Savoy ISD. Your right of use is limited to and conditioned upon your full and complete compliance with the Savoy ISD Student and Parent Chromebook Use Agreement, Savoy ISD Acceptable Use Policy, and Savoy ISD Student Code of Conduct, and Savoy ISD Student Handbook. (Documents available on the school website.)

#### Care

Students will check out a Chromebook at the beginning of each school year and will be responsible for keeping it charged and bringing it to school each day. Students must take care of the device and all accessories as lined out in the *Savoy ISD Student and Parent Chromebook Use Agreement*. Chromebooks must be returned at the end of the school year with case and charger and free from damage. Students who withdraw from Savoy must return their Chromebooks and accessories before withdrawal paperwork will be released.

### **Loss or Damage**

If the Chromebook is damaged, lost or stolen, you are required to report the incident and be responsible for any damages as required by the *Savoy ISD Student and Parent Chromebook Use Agreement*. A \$10.00 incident fee will be assessed for EACH individual damage incident. After three incidents of damages, parents will have the choice of paying for the replacement cost of the Chromebook or lose usage privileges. Accidents will happen, but deliberate damage to a Chromebook or not following the appropriate usage policy will result in discipline consequences and/or loss of use.
