

# **Cornerstone Montessori Elementary School - District # 4201**

## **Parent and Family Engagement Plan**

### **2025-26 School Year**

Cornerstone Montessori Elementary School/District 4201 is committed to the goal of providing quality education for every child in this district. We want to establish partnerships with parents and with the community. Everyone gains if school and home work together to promote high achievement by our children. Neither home nor school can do the job alone. Parents and families play an extremely important role as children's first teachers. Their support for their children and for the school is critical to their children's success at every step along the way.

#### **Part I. District Expectations**

Cornerstone Montessori Elementary School will put into operation programs, activities and procedures for the engagement of parents and family members consistent with section 1116 of the Every Student Succeeds Act (ESSA). The Cornerstone Montessori Elementary School/District 4201 agrees to implement the following requirements:

*On September 29, 2025 we will conduct a meeting prior to the first Schoolwide Parent Partnership Event.*
2. Cornerstone Montessori Elementary School/District 4201 will involve parents in the process of district and school plan, review and improvement [i.e. district plan, section 1112, schoolwide section 1114, and/or school improvement section 1116];
  - a. How will the school/district inform parents of the school report card?  
*We will post the school report card on our Website with a link to the MDE website.*
  - b. How will the district/school notify the parents that their child's school has been identified as needs improvement?  
*We would host a meeting/discussion and send a letter.*
  - c. How will the school identify students who qualify for Title I services?  
*We have a schoolwide plan, so all students benefit.*
  - d. How will the district/school involve parents of students in the identified sub-groups as part of the school support team?  
*We involve all parents, and we invite parents of children receiving Special Education Services and English Language Learner instruction to be part of meetings and discussions specifically related to those components of our program.*
  - e. How will the district/school conduct staff development for implementing effective strategies for parental involvement?  
*On October 16-17, 2025, the staff will participate in professional development aimed at giving conferences that engage the parents as partners in their child's academic progress and social emotional development, as a two-way exchange of expertise and information about the child. Staff will also be trained in the presentation and signing of the Title One School - Parent Compact.*
3. Cornerstone Montessori Elementary School/District 4201 will involve parents, in an organized, ongoing, and timely way, in the planning, review and improvement of programs under this part, including planning, review and improvement of the school parent and family engagement plan.  
*There will be opportunities during our District Advisory Committee Meetings for parents to receive updates to our progress relative to this plan and be invited to give input to said plan.*
4. Cornerstone Montessori Elementary School/District 4201 will offer a number of flexible meeting options, such as meetings in the morning or evening, and may provide, with funds provided under this part, child care or home visits, as such services relate to parental involvement.

5. Cornerstone Montessori Elementary School/District 4201 will provide the following necessary coordination, technical assistance and other support to assist in planning and implementing effective parent involvement activities to improve student academic achievement and school performance.

*Parents receive weekly news via NotifyMe, monthly newsletters via email and updates via the school website, and are invited to participate in quarterly Parent Partnership events that directly address Montessori philosophy and student achievement, often with students presenting their work or presentations.*

6. Cornerstone Montessori Elementary School/District 4201 will build the schools' and parents' capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents and the community to improve student academic achievement, through the activities specifically described below.

*As Cornerstone enters its fifteenth year, we have been able to assess constructive parent meetings, increase involvement and eliminate time that has been spent in less productive ways. We've learned and found ways to increase attendance and have a more formal system of taking and reviewing minutes to increase follow through and genuine improvement.*

7. If the schoolwide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the local educational agency.

8. Cornerstone Montessori Elementary School/District 4201 will provide support to parents of children served by the school district or school, as appropriate, in understanding topics such as the following.

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments,
- the requirements of Title I,
- how to monitor their child's progress, and
- how to work with educators.

*We have a Back to School Information Fair, Parent Orientations, monthly Parent Partnership Events, and we partner closely with the Montessori Center of Minnesota to provide access to Parenting and education workshops. Perhaps most importantly, we host parent observations of regular school days and provide de-briefing discussions following the observations to increase parent understanding of the Montessori philosophy and their child's progress. When staff attends seminars or workshops this information is shared with parents as well.*

9. Cornerstone Montessori Elementary School/District 4201 will provide parents of participating children, if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.
10. Cornerstone Montessori Elementary School/District 4201 will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement.

*Cornerstone's Literacy Specialist provides parents with strategies for reading with their children as well as on-going mentoring during the school year. Parents receive information on the use of FASTBridge for reading and math assessments for children.*

11. Cornerstone Montessori Elementary School/District 4201 will educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools.

*In addition to the specific training to engage parents as partners in conferences, staff participate in trainings from outside experts around issues that affect our families, such as poverty, inequity, homelessness, implicit bias and other crises. We have implemented a School Based Mental Health program for all children. We also invite parents to speak at parent events about their own areas of expertise relative to our community and school.*

12. Cornerstone Montessori Elementary School/District 4201 will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.

*Cornerstone partners closely with the Montessori Center of Minnesota and hosts events of all types to support parent engagement, such as the Early Childhood Screening that happens on site each year.*

13. Cornerstone Montessori Elementary School/District 4201 will take the following actions to ensure that Title I information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand.

*Cornerstone has made huge strides forward in our effort to make sure all of our documents and communications are translated into the languages our families use. Cornerstone's website is updated on a regular basis as new resources and information are developed. We continue to improve the site to provide more opportunities to distribute information to our community about programs and events.*

14. Cornerstone Montessori Elementary School/District 4201 will coordinate and integrate parental involvement strategies under Title I with parental involvement strategies under the following other programs:

*We partner with our local Head Start in placing or receiving children; we also partner with*

*the Montessori Center of Minnesota's Birth to Five Program to serve families in our community.*

15. Cornerstone Montessori Elementary School/District 4201 will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement plan in improving the quality of its Title I schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). *We conduct an annual survey offered on line and in paper format. We support parents having on line access here at school and make sure that the survey is in their language. We have also provided support in offering to read the surveys to parents who need that support.*

16. Cornerstone Montessori Elementary School/District 4201 will convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved,

*Our meeting will convene on September 29, 2025 prior to the first Parent Partnership Event; dinner and childcare are provided to support strong attendance.*

### **Part III. Shared Responsibilities for High Student Academic Achievement**
