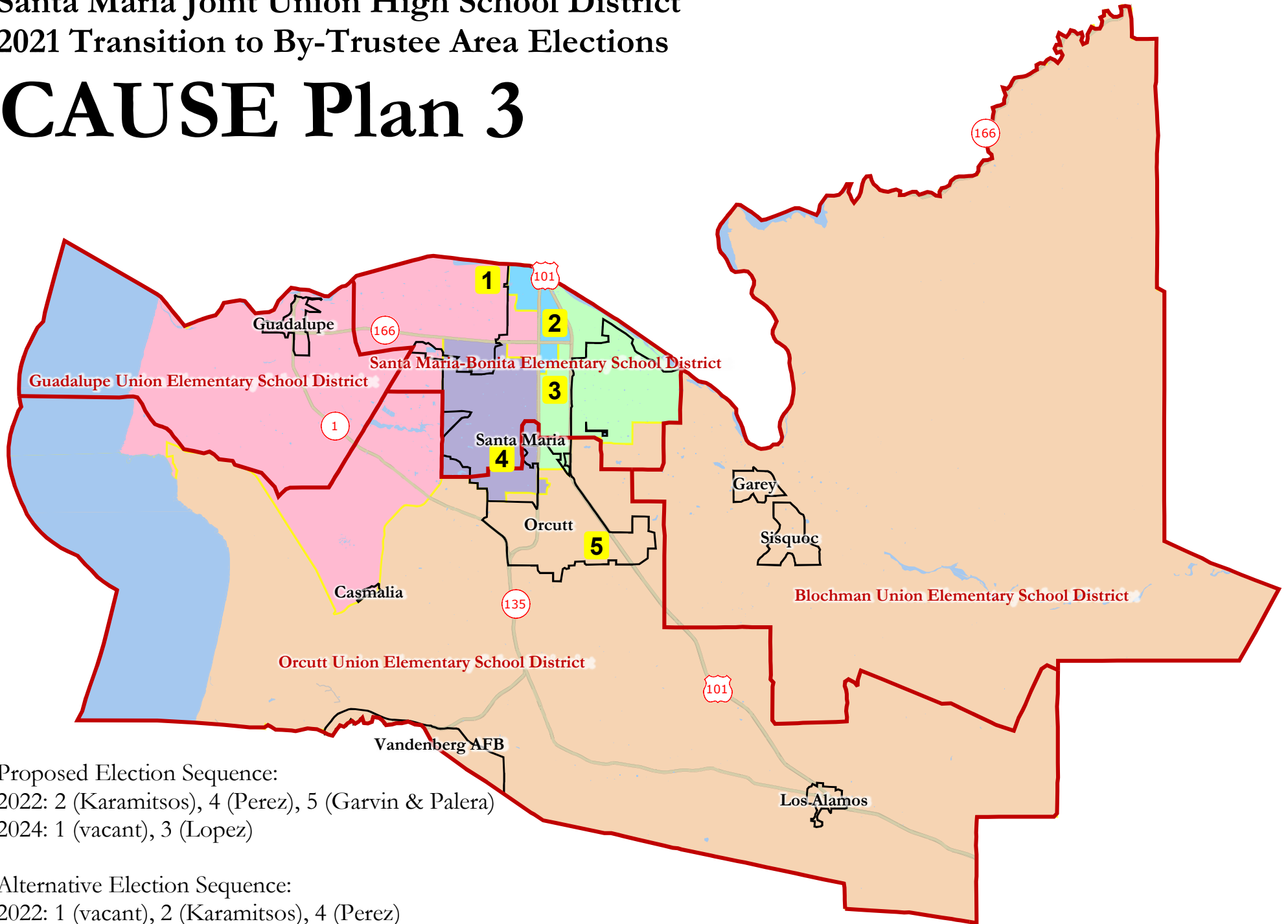

Dear members of the SMJUHSD Board of Education,

The Central Coast Alliance United for a Sustainable Economy (CAUSE) writes to you as a longstanding organization representing working-class communities of color in Santa Barbara County. Throughout our history we have advocated for voting rights for our communities from the school to federal level. This specific process is incredibly important as the board will decide on a map that will affect SMJUHSD's first district elections.

CAUSE, FLA and MICOP held a student forum to give youth an opportunity to share their ideas and priorities for the final map. The three maps we have submitted are drawn with their consolidated feedback.

Though there are three variations, all maps include the following priorities identified by the youth:

1. Ensuring a strong district for Northwest Santa Maria whose needs have gone underrepresented on the board for too long. District elections will finally give folks a chance to voice their shared priorities and concerns given that a majority of families in the northwest are Latino, working class and immigrant families.
2. Placing Guadalupe, which has also long been underrepresented on the board, in the district with Northwest Santa Maria. Youth believe that families in Guadalupe will be best represented here as they share similar linguistic and cultural backgrounds.
3. Creating at least 3 Latino majority Citizen Voting Age Population (CVAP) majority districts to comply with the federal Voting Rights Act and ensure that Latino families have the voting power they need to elect representatives of their choice.

We have attached below three maps which meet the criteria above.



Map 1

The proposed districts 5 and 4 unify working class and immigrant families, many of which are farmworkers, to ensure their similar cultural and linguistic needs are prioritized by their representative. Many families in this district primarily speak Spanish or Mixteco, are low-income and rely on free and reduced lunches, are students without access to computers at home and deal with home insecurity. To ensure Guadalupe has the best representation possible, it is connected to Northwest SM in district 4, as they share the most in common. For population balance, district 5 brings in the southern portion of Northwest Santa Maria.

The proposed district 3 consolidates relatively newer homes in our community in the southwest, while taking into consideration the high percentage of Hispanic population residing here. This would also be the district with the highest percentage of Black and AAPI residents.

The proposed district 2 encompasses the eastern side of Santa Maria that represents a more balanced and diverse population of both white and minority communities. This area further contains middle-income households.

The proposed district 1 keeps Orcutt whole along with the southern portions of the areas represented by the district. Many families in this district have high levels of college education, homeownership, and income and predominantly speak English in their homes. These sorts of factors coincide with a sense of stability for students that other families may not have access to.

Map 2

The proposed district 4 prioritizes keeping the most northern part of NW Santa Maria whole. Thus district 5 brings in the southern portion of Northwest Santa Maria.

The proposed district 2 extends to the neighborhoods surrounding the airport to prioritize keeping the communities in the middle of the city whole. Thus district 3 extends a few blocks past Broadway.

The proposed district 1 remains unchanged.
