1. Call to order.

A regular meeting of the Onaway Area Community School District's Board of Education was held in the Media Center. Called to order by President Mike Hart at 6:00p.m. January 21, 2025.

4. Approval of Agenda.

Hart asked if anyone had anything to add to the agenda.

Anette Porter asked that board Correspondence be added. Hart added this topic after Citizens Present Public Comment Time as item 7.

Moran moved to approve the amended agenda, supported by Veihl. All in favor. Motion carried.

- 5. Approval of minutes for regular/special meetings.
 - a. January 14, 2025 Regular meeting minutes

Veihl moved to approve the regular meeting minutes from January 14, 2025, supported by Moran. All in favor. Motion carried.

6. Citizens Present Public Comment Time - For Agenda Items Only.

Wayne Vermilya addressed the board with two agenda items. No action taken.

7. Board Correspondence.

President Hart read a letter he received in the mail (letter attached) and said he also received a text message from one of the union representatives stating the same. Discussion held.

- 9. Closed Session for the purpose of discussing Attorney/Client Privileged Information regarding the pending arbitration case with the former superintendent.

Veal moved to enter closed session at 6:27p.m., supported by Stacey Porter. All in favor. Motion carried.

10. Return to Open Session

Veal moved to enter into open session at 8:07p.m., supported by Veihl. All in Favor, Motion carried.

11. Motion made in open session.

Veihl makes a motion to wave attorney client privilege on the email we received from attorney Daniel Martin, supported by Veihl. Discussion held to clarify attorney client privilege on said email only.

Roll call vote: Moran- yes, Veal- yes, Kowalski- yes, Veihl- yes, Stacey Porter- yes, Annette Porter- yes, Hart- yes
Full email read by Veihl outlining the two options given.

Summary of Option #1:

Paying Mrs. Horn the difference in Onaway Superintendent salary at her current job, which amounts to approximately \$22,790.44 per year, plus her attorney fees of \$7,187.37 for a total payout of approximately \$30,000.00. Also, reinstating her as OACSD Superintendent beginning July 1, 2025.

Summary of Option #2:

Paying Mrs. Horn the difference in her salary at her current job and her Onaway salary over the 5-year term of her Onaway contract, which amounts to about \$112,500.00 in round numbers. Plus, pay loss of pension benefits based on her current lower salary, which she estimates at just under \$39,000.00 and reimbursement of her legal fees (\$7,187.37). Altogether, Option 2 is approximately \$157,00-160,000.00.

Veal makes a motion to direct the school's attorney to prepare an arbitration settlement agreement consistent with Option #1 subject to review and appeal by the Board of Education at a future meeting, supported by Stacey Porter. Discussion held.

Roll call vote: Moran- no, Kowalski- no, Veihl- no, Veal- yes, Stacey Porter- yes, Annette Porter- yes, Hart- yes. Motion carried.

Wayne Vermilya presented to the board. No action taken.

Scott Hill presented to the board. No action taken.
