Curriculum and Instruction

1. NC Math 1 and NC Math 3 state assessment scores for the 2018-2019 school year Catherine Berry, Assistant Superintendent for Curriculum & Instruction, and Beth Davis, Director of Testing and Accountability/PowerSchool, presented information regarding NC Math 1 and NC Math 3 state assessment scores for the 2018-2019 school year. After review, a request was presented to the board for their approval to amend the current policy to include the use of the data provided by NCDPI to calculate an exam grade for NC Math 1 for the 2018-2019 school year. As a result, students enrolled in NC Math 1 during the Fall 2018 semester will receive a final grade based on the weighted average of the Quarter 1 grade, the Quarter 2 grade, and the computed exam score. Students enrolled in NC Math 1 during the Spring 2019 semester will receive a final grade based on the weighted average of the Quarter 3 grade, the Quarter 4 grade, and the computed exam score. Fred Burgess made a motion and the motion was seconded by Brian Biggs to approve the request to amend to include the use of data provided by NCDPI to calculate an exam grade for NC Math 1 for the 2018-2019 school year.
