# **CALL TO ORDER**

Dan Winn made a motion to approve the Consent Agenda as presented, Randy Fulton seconded; the motion passed unanimously.

#### **REPORTS & PRESENTATIONS**

- 4. Board Chair's Report Superintendent Evaluation Letter Randy Fulton read the Superintendent Evaluation Letter aloud. No action was taken.
  - 5. Schools & Student Services Reports
    - Presenter: HMS & Slater Summer School

Slater Principal, Stephanie Lardy presented a quick summary of the great growth of students that participated in summer school. She thanked all the teachers, para pros, cooks, and bus drivers that helped make the program a success.

6. Superintendent's Report

<u>Masks:</u> Mr. Quick has attended many superintendent meetings, and met Monday with Representative Owens and Findley. The new mandate from the state focuses on consequences. There will be more announcements coming this week in regards to sports and school. He understands the frustration with masks.

Retention: He compared last year's data versus this upcoming year.

<u>Summer School:</u> A very large group participated and it was a phenomenal program. Food services worked hard and supported families. They served 4,628 meals this past summer.

<u>Custodial/Maintenance:</u> There were many accomplishments including deep cleaning, waxed and refinished most gym floors, painted. The crew worked hard and had great attitudes. We hired three students to work on custodial and grounds maintenance.

TVCC Building Follow-up: Mr. Quick said the building belongs to them and it will stay as the EOU/TVCC building. It opened a conversation with TVCC and they are committed to stepping up their services for our district.

### 7. Work Session Update

- > A new committee will be formed and recruiting will begin soon.
- > There were also lengthy discussions on SIA funds, facilities, principal reports, and board goals.
- Mr. Quick said we have local control over what we teach. CRT is not in HCSD#3 curriculum and we are not intentionally teaching CRT. We want students to be critical thinkers.
- Mr. Quick said the Sex Ed curriculum from ODE is taught as sex abuse prevention and age appropriate. Trained counselors in the district are teaching Erin's Law, but notices are sent to parents beforehand.

#### 8. Masks

- Mr. Quick said TSPC could pull administrators' licenses if the mask mandate is not upheld. OSBA advised the district to not take action or risk getting on OSHA's radar. We will model integrity.
- > Rob Frank wants a resolution to not enforce the mask mandate.
- > Wendy Reid said we have a duty to both sides.
- > Dan Winn agrees with Rob but does not know how to enforce it.
- > Randy Fulton said the board took an oath to uphold the law. He said we cannot jeopardize employees and we cannot say anything about the masks.

Rob Frank made a motion to pass a resolution to not enforce face coverings/masks or enforce documentation of vaccines/immunizations.

Dan asked what Steve Quick was supposed to tell teachers? Rob answered it would send a clear message.

Joe Wright seconded the motion. Rob and Joe voted for the motion; Dan, Wendy, and Randy opposed it. The motion failed.
