To Whom It May Concern:

As a result of the roof damage at York West End Jr. High School and Sumter Central High School, there are areas that compromise the public health and safety of staff, students, and the public, as such, I recommend an Emergency is declared to perform repair and/or replacement of interior construction to the affected areas, this may include electrical, mechanical, carpentry, casework, wall, floor, and ceiling finishes.

In addition, the significant threat of COVID-19 and the more contagious Delta variant spreading across the US has created a need to reevaluate every aspect of campus operations. To continue to limit direct contact in high traffic areas and limit COVID-19 transmission, I recommend an Emergency is declared to retro fit restrooms and other high traffic areas with touch-free fixtures. I believe that this work will continue to provide the best solution for protecting the public health and safety, while attempting to return to normal in person learning environments.

Sumter County Board of Education intends to issue an Agreement Between Owner and Architect with Lathan Associates Architects, P.C. for architectural/engineering services and intends to contract with a contractor for construction services to address the needed repairs.

The Sumter County Board of Education met on August 26, 2021, at 5:00 p.m. via Zoom. At this meeting, the Board took action and approved an Emergency Declaration to address repairs needed due to water damage for York West End Jr. High School and Sumter Central High School and the touch-free fixtures for Kinterbish, Livingston, and York West End Jr. High Schools.

Agreement Between Owner and Architect - Special Provisions Attachment "A"

- Basic Fee shall be the Architect's compensation in full for satisfactorily providing Basic Services (A-E) as
 defined in the Agreement and Standard Articles, Article 3 DCM Form B-2A. The Basic Fee includes normal
 Structural, Mechanical and Electrical Engineering Design. Basic Fee also includes Civil Engineering for site
 drainage and grading only.
- Basic Fee Rate, indicated on page one, is based upon the tentative Cost of Work. Actual Fee percentage shall be adjusted in accordance with the current edition of the "Manual of Procedures of the Division of Construction Management" to reflect the actual cost of the work including Change Orders and Estimated Sales Tax Savings from DCM Form C-3.
- 3. To provide for Fair Market Value, it is hereby agreed that the Cost of the Work, to be used as the basis for determining fees for architectural services, (OPTION 1) shall include the associated Estimated Sales Tax Savings Amount as provided on DCM Form C-3 provided at bid by the successful bidder, in addition to any Owner provided/purchased materials and/or labor OR (OPTION 2) if the Owner chooses to appoint the General Contractor as their Purchasing Agent, shall include all material costs and labor provided and/or paid direct by the Owner in addition to the Estimated Sales Tax Savings Amount as provided on DCM Form C-3 provided at bid by the successful bidder. The choice of option shall be determined by the method of material purchasing administration which is utilized with the Construction Contract.
- 4. Adjustment for Major Renovation. An increase of up to 25% in the Basic Fee Rate will be allowed for major renovation projects. This adjustment is intended to provide compensation to the design professional for the added effort required to investigate and develop drawings of existing conditions and other additional work required for renovation. A project is considered a major renovation if more than 50% of the construction cost involves renovations and alterations.
- 5. Reimbursable Expenses and Additional Services shall be billed at 1.10% of direct cost and shall include such items as miscellaneous engineering (See Special Provision 6, below), advertisements for bid, printing, and shipping. Expense of long-distance travel (beyond 50 miles of Hoover, ΛL) in connection with the Project shall be billed at the State of Alabama Current Allowable Rates without markup.
- 6. The following engineering, consultant's services and other costs are excluded from Basic Fee and will be paid by the Owner with markup as defined in Special Provision 5:
 - Architect's On-site Representative for the following;
 - Geotechnical Engineering (including IBC Special Inspections and Construction Material Testing).
 - Civil Engineering including boundary survey, topographical survey, as-built survey, right of way engineering, permitting, and site utilities.
 - Architectural and Engineering Peer Reviews required for Storm Shelters.
 - Engineering not specifically mentioned as included within Basic Fee is excluded.
- 7. The Owner may employ Third Party Consultants that are not included within the Basic Fee. The Architect shall be indemnified by Third Party Consultants under separate contracts with Owner outside of this Agreement. Fees for third-party services shall be paid directly by the Owner by direct billing from the Owner's Consultants, excluded from Reimbursable Expenses and Additional Services of this Agreement.

- 8. All project alternates will be billed per standard fee rate set for its respective type of construction. If alternates are designed and not constructed, then 75% of said fee shall be billed.
- 9. Construction that is designed and self-performed by the Owner will be billed based upon Fair Market Value estimate, as defined in Special Provisions 3, and per standard fee rate set for its respective type of construction. If construction to be self-performed by the Owner is designed and not constructed, then 75% of said fee shall be billed.
- 10. The maximum not-to-exceed amount for this agreement's basic services shall be \$93,365.00 based upon the Owner's tentative Cost of Work. Once awarded, this fee will be adjusted to the actual cost of work as is previously outlined in Special Provisions. Reimbursable expenses under this agreement shall be an additional maximum not-to-exceed amount of \$4,500.00 as outlined in Special Provisions 5 & 6. Once awarded, this fee will be adjusted to reflect any changes in permitting or additional fees due to the actual cost of the work. Additional services under this agreement shall be an additional maximum no-to-exceed amount of \$ N/A. Estimated total compensation under this agreement including basic services, reimbursable expenses, additional services shall not exceed \$97,865.00 unless increased through future amendments for actual cost of work, actual reimbursables and future change orders.
- 11. Betterment: If, due to Architect or consultant negligence, a required item or component of the Project is omitted from the construction documents, the Architect shall not be responsible for paying the cost required to add such item or component to the extent that such item or component would have been required and included in the original construction documents. However, the Architect or consultant will be responsible for paying the "premium cost" of such addition, which is the difference in cost that the Owner pays to add the item or component and the cost that the Owner would have paid for the item or component had it been included in the Bid Documents. In no event will the Architect be responsible for any cost or expense that provides betterment or upgrades or enhances the value of the Project.



In accordance with your request, EMC, Inc., performed a site visit on August 12, 2021, to perform some general observations within the school that have exhibited mold/fungal growth. We were escorted by Mr. Holder and Dr. Nord at that time. During the site visit we collected twelve random and representative surface samples using BioTapeTM that clearly indicated mold/fungal growth. These samples were forwarded overnight to an independent and qualified laboratory (EMSL Analytical, Inc.) to perform a microscopic examination to help identify the various mold spore types along with the overall spore count/presence. The laboratory direct examination is designed to identify mold genus types but not species. Since there is literally thousands of mold species found in North America, further analysis would be required. The following mold types listed below are the primary mold types identified within the samples collected and were found in "High" spore count concentrations.

Aspergillus
Penicillium/Talaromyces
Cladosporium
Acremonium-like
Scolecobasidium/Ochroconis-like

All of the listed types above exhibited fruiting structures (bodies) and/or hyphae present which are associated with active mold growth which in-turn produces more mold spores. As long as there is an adequate presence of moisture along with an adequate food source, mold will continue to grow. Mold will grow on most any material that's is organic, or has an organic substance present, even dust particles.

Mold is divided into three main categories:

Allergenic - molds that can cause an allergic reaction or asthma symptoms. Typical reactions may include, sneezing, itchy or watery eyes, runny nose, nasal congestion and can also impact individuals with sensitive immune systems. Aspergillus, Cladosporium and Penicillium are three common allergenic mold types.

Pathogenic - molds that can cause infections in humans. These molds can impact both immune compromised individuals and healthy individuals.

Toxigenic - molds that can produce "mycotoxins". Mycotoxins are a chemical by-product during the metabolic process. The metabolic process is any process performed to maintain life, to live, reproduce, etc. The mycotoxins can have toxic effects on humans and animals.

Typically, many mold types have very little impacts on people with healthy immune systems and are not suffering from allergies or asthma. As with any project, some basic safety precautions need to be considered when disturbing mold contaminated areas. We recommend that anyone cleaning or removing materials with mold should wear rubber gloves and/or disposable latex gloves along with properly wearing adequate respiratory protection such as a N95 face mask or respirators with HEPA type cartridges/filters such as P100. Depending on the type of work activities, eye protection may also be warranted. We also recommend disposable clothing be worn while performing cleaning and repairing mold impacted areas. Disposable coveralls/suits like Tyvek® made by DupontTM can be easily purchased. However, these suits come in breathable and non-breathable types. Suits can be a health hazard when it comes to heat stress. We recommend that a consultation with a medical physician or specialist be performed, especially if someone has heart, pulmonary or any other known health issues prior to donning a suit, wearing respirators and working in warm and hot conditions. The hiring of a qualified and reputable contractor may be the best option for schools, in some cases.

EMC is not aware of any regulatory or widely accepted industry standards for airborne mold concentrations within schools. One reason for this lack of standards is that each person reacts differently to each of the many types of mold. An airborne concentration that has no noticeable impact on one person may cause an allergic reaction in another. Evaluation of airborne mold data is therefore generally based on comparison of airborne mold concentrations within a building to mold concentrations in the air outside of that building. If requested, EMC can perform some air sampling once cleaning and any repairs have been performed to evaluate the indoor spore counts.

Limitations

This report has been submitted based on EMC's general observations and limited number of surface samples collected. A comprehensive study has not been performed by EMC, Inc., at this time, which includes the collection of indoor and outdoor air samples, monitoring and/or collection of ambient air temperatures, dew points and relative humidity readings with the building(s).
