BOARD MEETING MINUTES

The Pickens County Board of Education met on Monday, October 16, 2023, at 6:00 PM at the Pickens County Board of Education. Board members John Brandon, Gene Dawkins, Annie Jackson, Frankie Spencer, and Sam Wiggins were in attendance. Superintendent Jamie Chapman conducted the meeting. Other participants were Administrator of ESSER and Instructional Technology Chan Mullenix, Associate Superintendent Vanessa D. Anthony, and CSFO Jennifer Shirley.

Call to Order and Open Meeting (Board Chairperson)

1. Regular Business

- **A.** Approve Agenda: On a motion by Gene Dawkins and seconded by Sam Wiggins, the Board unanimously approved the agenda.
- **B.** Approve Minutes (September 11, 2023): On a motion by Sam Wiggins and seconded by John Brandon, the Board unanimously approved the minutes.

2. Reports

A. Vaping Procedures: The recommended consequences for the possession, distribution, and usage of vapes by students are as follows:

CLASS 3.01 OFFENSE CONSEQUENCES

First Offense:

Possession or Distributing vapes with THC or any other drug

- o 10 days of Out of School Suspension (OSS) with unexcused absences and "0" on assignments
- o Recommendation of Expulsion to the Assignment Committee
 - 45 days of expulsion with services (including OSS days)

Using vapes with THC or any other drug

- 10 days of Out of School Suspension (OSS) with unexcused absences and "0" on assignments
- o Recommendation of Expulsion to the Assignment Committee
 - 90 days of expulsion with services (including OSS days)

Second Offense:

Possession or Distributing vapes with THC or any other drug

- o 10 days of Out of School Suspension (OSS) with unexcused absences and "0" on assignments
- o Recommendation of Expulsion to the Assignment Committee
 - 90 days of expulsion with services (including OSS days)
- o The student case file will be turned over to the Assistant District Attorney's office.

Using vapes with THC or any other drug

- o 10 days of Out of School Suspension (OSS) with unexcused absences and "0" on assignments
- o Recommendation of Expulsion to the Assignment Committee
 - Expulsion with services for one calendar year
- o The student case file will be turned over to the Assistant District Attorney's office.

Third Offense:

Possession, Distributing, or Using vapes with THC or any other drug

- o Recommendation of Expulsion to the Assignment Committee
 - Expulsion without services for one calendar year
- o The student case file will be turned over to the Assistant District Attorney's office.
- **B. SRO Update**: Following the commission meeting last month, a number of invoices were submitted for payment to CSFO Shirley.
- **C. AASB Delegate Selection**: Board members agreed to not nominate a delegate or alternate delegate for the upcoming winter conference.
- **D.** School Superintendents of Alabama Update: The SSA Conference was held the week of October 11-13, 2023 in Florence, AL. One of the main discuss topics was the large surplus of funds that would be available for the FY25 school year. SSA will work to secure a substantial amount of these funds for K-12 education. Another topic of discuss for the 20 school systems that may have to enact Reduction in Force because of a lack of revenue. The third topic of discussion was supplemental grants that are due to the SDE by Friday, October 20th.
