# Joint Agreement for Rotation of Sending District Representation - Salem City BoE

The Joint Agreement for Rotation of Sending District Representation to the Salem City Board of Education between Lower Alloways Creek, Mannington, and Elsinboro Boards of Education for the calendar years 2025-2027. Collectively, the three Boards of Education meet the 15% standard for two representatives on the Board per NJSA 18A:38-8.2.

Salem City Board of Education Representative - First year (2025) of three- year agreement with Lower Alloways Creek and Mannington Township Boards of Education

For the 2025 year, collectively between Elsinboro, LAC, and Mannington, student enrollment meets the 15% required to allow for two representatives to represent all three districts. Elsinboro represents 3.37% (11 students) of the 326.5 students attending grades 9 through 12 at Salem City High School. Based upon the last representative rotation cycle, Lower Alloways Creek and Mannington are the 2025 representatives. Mannington is deferring its representation to Elsinboro.
