




### Latest Cumberland County Data




### Latest Franklin County Data

### District Recommendations


- Relax Social Distancing Guidelines
- Transition Grades K-5 from hybrid learning to Full-time In-Person learning 4 days per week (December 7<sup>th</sup> assuming favorable conditions)
- Transition Grades 6-12 from virtual learning to Full-time In-Person learning 4 days per week (December 14<sup>th</sup> assuming favorable conditions)
- Quarantined staff would teach from home with student class supervised
- Stagger elementary and secondary transition start dates
- One month planning and preparation
- Modify HS master schedule
- Modify student scheduling
- Modify MS master schedule
- Modify MS student team assignments (move some students to balance classes)
- Develop a MS virtual team (Based on Halls-to-Home #'s)

### District Recommendations Continued


- Use virtual team classrooms to split high class sizes for 7<sup>th</sup> and 8<sup>th</sup> grade science and social studies.

- Extensive cleaning and sanitizing on Wednesday for all buildings

- Hire lunchtime aides
- SAIS may eat in cafeteria







### Secondary Parent Survey Data








## Elementary Teacher Survey Data






### District Needs – Personnel Existing Solutions

Classroom Assistants: Make CBA changes to attract more candidates

**Custodian:** individual movement will increase existing capacity with previous board action. (previously approved)

**Food Service:** Fill as many vacancies as possible, can work with existing capacity but lunch offerings/options would be much less. Suspend curbside service.

# Health and Safety Plan Draft Revisons

#### Currently:

- "Turn desks to face the same direction (rather than face each other)"
- Change to: "Turn desks to face the same direction when feasible"

### Currently:

- "desks to be six feet apart"
- Change to: "desks will be spaced to the greatest extent possible"

### Currently:

- "However, each group must be separated from the other by an empty space of at least 30 feet. Groups should not combine for activities at any time"
- Change to: remove statement to allow for lunches in the cafeteria

### • Currently:

- "Students must not be brought together in assemblies, field trips, or other group gatherings outside their class group, unless the distancing of 30 feet between groups can be maintained"
- Change to: "Students must not be brought together in assemblies and field trips"
  - This is to ensure that students can eat lunch in the cafeteria

- Currently
  - "One-way hallways"
  - Change: Statement needs removed
- Currently
  - Referring to social distancing in the cafeteria "with students sitting on oneside tables facing the same direction"
  - Change to: Remove statement
- Addition:
  - "Adults supervising the cafeteria will constantly rotate through the cafeteria and stand in one location for no more than six (6) continuous minutes in order to avoid close contact as defined by DOH"

- Currently:
  - "One-way hallways"
  - Change to: Statement needs removed
- Currently
  - "Bathroom considerations: limit student access"
  - Change to: "Elementary bathroom consideration: limit student access"

### Currently

• "Primary (K-3) buses will run at a significantly reduced normal occupancy due to alternating days of attendance, parent drop-off and pick-up.

Intermediate grade (4 & 5) and secondary grade (6-12) buses will run at drastically reduced occupancy. Initially due to only IEP students attending facetoface, all others attending virtually. When schools can transition to an A/B schedule, occupancy will may be reduced to under 50% combined with student drivers, parent drop-off and pick-up."

- Change to: "Buses will run
  - "Buses will run with less than normal occupancy due to families choosing Halls-to-Home and Shippensburg Area Virtual Academy"

### • Currently:

- "When able to transition to an A/B cohorts, < 50% normal occupancy and some parents choosing the Shippensburg Virtual Academy."
- Change to: "When able to transition to an A/B cohort (or full-time face to face) classrooms will be at less than normal occupancy due to families in Halls-to-Home and SAVE."

- Currently:
  - "Temperature check upon arrival at school (all students and staff)"
  - Change to: Remove statement

- Currently:
  - "Schools may allow students to remove their face coverings when students are eating or drinking when spaced at least 6 feet apart"
  - Change to: "when students are eating or drinking"

- Currently:
  - "Staff available to take temperatures"
  - Change to: Remove statement
