All bids will be opened promptly on May 6th, 8:30 a.m. CT, the proposed bid amount recorded and a copy of each proposal provided to Board members for review. All proposals are to be F.O.B. Jasper, Tennessee. A product data sheet for each model specified in the bid must be included in the proposal. Nonconforming proposals or proposals submitted after the deadline will not be considered. The decision whether to award a contract to provide equipment/service to complete the project will be announced following the Boards review of the proposals. The Board reserves the right to accept or reject any or all proposals submitted as deemed solely by the Board to be in the best interest of the school system and the community and contingent upon approval of purchase funds by the Marion County School Board and County Commission. - All ground level Exterior Windows and doors.
- Turn Key Installation. Proposal must include any accessories needed for the installation.
- Vendor responsible for any broken glass during installation.
- Vendor will meet individually with School Principal and SRO to determine areas to be covered.
