Description of Project:

Project Name: White Pine County School District – New K-8 School

Estimated Area of projects: New K-8 School of approximately 80,000 to 100,000 sf

Estimated Construction Budget: \$80 million to \$85 million

The anticipated time frame for the Pre-construction phase will be December 2025 through Spring 2026. Bidding/GMP Phase is anticipated for Summer 2026. Construction Phase is anticipated commence in the Fall 2026 with completion by Summer 2028. The WPCSD reserves the right to change the project size, scope, budgets and schedules indicated above.

Description of Construction:

The proposed work includes the construction of a new K-8 (combined elementary and middle) school of approximately 80,000 to 100,000 sf on 20+ acres for White Pine County School District. This new school will also include new outdoor playground/recreation areas, parking and other required site infrastructure and development to support the project. This school will replace both the David E. Norman Elementary School and the White Pine Middle School, each respective school is well over 100 years old. The new school will be located near the existing High School campus.
