All initial parent-teacher conferences will be held first semester. During these conferences, teachers will discuss quarterly academic curriculum and grade level expectations.

Parents receive a student handbook annually and a monthly school bulletin. Each quarter, parents will receive mid-quarter progress reports to keep them informed of their student's academic progress.
