Follow-Up with Non-participating Fairview Intermediate families: Parents who do not attend meetings or do not complete the surveys or packets will have follow up from staff through several channels including:

- Individual outreach from classroom teachers via ClassDojo
- Reminders during dismissal
- Phone calls from office staff encouraging completion

These layered approaches ensure that the school reaches as many families as possible and supports full participation in the engagement process.

During these family nights as well as our annual Title meetings, parents receive information on curriculum and learning standards assessments. Additionally, parents are able to monitor student progress through our Infinite Campus parent portal and many teachers also use Class dojo which gives a real time view of student progress and behavior.

Parents are able to obtain resources from their child's classroom teacher at any time during the school year. Additionally, during our parent meetings and curriculum nights, our teachers provide families with strategies to assist their scholar as well as give resources and provide hands-on assistance.
