3. <u>Technology Presentation</u>

Dr. Troy Stevens, Technology Coordinator and Mrs. Sheri Woodall, Director of Curriculum and Instruction presented on "Student Screen Time with AI". They presented the pros and cons of screen time and shared with the Board that the District uses Go Guardian to track student activity while using their District account. Screen time per grade for March 6th between 7:30 a.m. and 3:30 p.m. was presented along with screen time for all other times outside of 7:30 a.m. and 5:30 p.m.

A discussion occurred between the Board and Administration in reference to what Go Guardian can provide to the District and parents regarding student screen time and websites they are visiting. Mr. August shared that Go Guardian is designed to monitor websites, not analyzing screen time. Dr. Stevens stated that he spoke with a competitor of Go Guardian and they cannot provide this information to districts either.
