- Discussion of expanding our charter to  $7^{th}$  and  $8^{th}$  grade
  - This wouldn't lock us in, but would give us an option if UST authorized this expansion. Starting a serious conversation/engaging in this process will move us forward, no matter what happens.
  - We haven't talked to UST about this for at least three years.
  - Could we start the conversation before applying? We need to know if the application would go through.
  - Question: If application is denied, is there a waiting period before resubmission? Nothing in manual that we have seen yet.
  - We would need to apply the first business day in June in order to start the following year – this seems awfully ambitious for this year, but we could have the conversation started.
  - Does this go to the Development and Engagement committee for more work too? This seems like the right way to go.
  - How do we get commitments from families when we can't guarantee we could have a program?
  - Much discussion of how to have compelling conversations and how to engage families
  - Surveys are tricky
  - Next steps:
    - Tyler, Alyssa, Expansion Task Force will meet

- Alyssa will contact UST to set up a meeting about a possible application.
- o Timeline?
  - These surveys and conversations should happen before the end of the school year.
