I UNDERSTAND THE FOLLOWING: (1) A transfer approval is for the entire school year and my child MUST attend the requested school no less than one semester. (2) An approved transfer is in effect until the Supervisor of Child Welfare and Attendance is notified in writing of the request to return to the home school. (3) If I change my request about the approved transfer, I MUST provide written notification to the Supervisor of Child Welfare & Attendance. This request should be received at least 30 days before the new school year or second semester begins. (4) An approved transfer means that any child will be assigned to the requested school. (5) All LHSAA eligibility rules will be adhered to in accordance to an athlete's eligibility to play sports at the requested school. **Students must be withdrawn from their home school in order to enroll in M to M approved school in 2026-27 if they are a new M to M student only.**

M-to-M Transfer Leaflet

K-12

- To qualify, the student's race must be in the majority at the home zoned school and in the minority at the requested school.
- An African American student zoned to a predominantly African American school can be granted a transfer TO a predominately WHITE school only.
- A White student zoned to a predominantly white school can be granted a transfer TO a predominantly African American school only.
- If a child's race is already in the minority at a school, an M-to-M Transfer cannot be granted to any school.
- M to M transfer eligibility is determined by the ethnic ratios at schools as of May 26, 2026 for the 2026-27 school year.
- Once a student is approved, they remain eligible for the entire time they are in that school. **They do not need to apply annually. However, when they move onto the feeder school, they must reapply.**
