4. D. P. Cooper Charter School – Drainage problem
5. D. P. Cooper Charter School – Roof leakage
6. WC Magnet School of the Arts – Hot water heater leaking
7. WC Magnet School of the Arts – Relocating playground equipment
8. WM Anderson Primary –Renovation of cafeteria to accommodate new students (Food Services will fund.)

Dr. Kerry Singleton recused himself from discussions involving D. P. Cooper Charter School.

Update on 2015-2016 Budget Information

Mr. Thames explained that the administration had performed all recommendations made by the Committee, but there was still \$1.3 million shortage in balancing the budget. The administration provided information to support the budget findings.
