Notes to Enumerators:
 1. Section 4027 as amended in 1903 governs the taking of the school census.
 Enumerators shall not include in the census the names of any child or children in reformatories or prisons, nor the names of any child or children in asylums, almshouses, or other charitable institutions, except as follows:
 (a) Children in such institutions who regularly attend the public schools.
 (b) Children who have been committed to such institutions on account of delinquency, but who are being educated in the public schools.
 (c) Children who are being educated in the public schools, but who are being supported by the State or Federal Government.
