CADET AGREEMENT

I, _____ voluntarily enroll in the Carroll County Air Force Junior Reserve Officer Training Corps (AFJROTC) program, and I will:

1. Wear the Air Force uniform issued to me a minimum of once a week (*Wednesday*) and on special occasions as required by the SASI or ASI.
2. Maintain the uniform in a clean and attractive manner *at all times*.
3. Maintain my hair and personal appearance within published GA-20062 AFJROTC standards.
4. Abide by Carroll County High Schools student rules of behavior and refrain from behavior that will discredit the school, the JROTC Corps, my family, and me.
5. Abide by GA-20062 AFJROTC rules and instructions.
6. Attend and participate in all classes *unless excused* in accordance with school policy.
7. Accept monetary responsibility for the issued uniform(s), books, and equipment if damaged or lost while in my possession due to any circumstance(s) other than normal wear and tear.
8. Maintain published AFJROTC academic standards.
9. Turn in government issued uniform(s), books, and equipment as directed by the SASI or ASI.
10. Attend the *required* following activities (*each parade counts for two class grades*):
 - a. Parades – may include Carrollton Christmas Parade and MLK Jr. Parade, among others as determined by the SASI or ASI.
 - b. Annual Military Ball
 - c. End of Semester Promotion Ceremony
 - d. Annual Awards Ceremony
 - e. Any other function/activity stated as required by SASI or ASI

I understand that my **failure** to abide by this agreement may result in: probation, demotion, removal from cadet position of responsibility, not being permitted to participate in AFJROTC field trips and extracurricular activities, no military training credit, and/or disenrollment from AFJROTC program with a grade of "F".

I further understand that to be eligible for AFJROTC field trips I must not have been in ISS or OSS prior to the field trip and I must have a passing grade in ALL classes.
