Board of Director Goals

- The school board will seek to openly communicate with each other, the school, and the community in order to have continuous improvement so that students can achieve better than they ever have.
- The school board will support quality educational practices that allow all students to achieve at high levels through multiple pathways.
- The school board will endeavor at all times to see that the school has adequate financial support within the capabilities of the community and state in order that every child may receive the best possible education.
- The board will seek effective budget processes, both short and long term, to ensure meaningful outcomes that are future oriented.

Historical Note:

- 60 years ago, April 1960: The School Board voted to ask the two towns for \$225,000.00 to build the new consolidated school.
- 59 years ago, May 1961: The Board made their official inspection of the new consolidated school building and voted to allow the Class of 1961 to hold their graduation in the new building.
- 53 years ago, April 1967: The Board voted unanimously to declare a "State of Emergency" in the district due to increased enrollment caused by the closing of the Sacred Heart Academy and St. Anthony Elementary School. 106 new students were added to the current 191 student population of SAD #12. (SAD 12 appealed to the State of Maine Legislature for emergency relief see the attachment)
- 51 years ago, May 1969: The Principal, Mr. Karwowski, made a presentation to the School Board concerning boys' haircuts in the school.

Legislative Document

STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SIXTY-SEVEN

AN ACT Relating to Compensation of State Aid for School Administrative District No. 12 (Jackman and Moose River-246).

Emergency preamble. Whereas, School Administrative District No. 12 currently enrolls 191 pupils; and Whereas, a decision has been made to close Sacred Heart Academy and St. Anthony Elementary School in Jackman; and Whereas, 106 pupils resident in the Town of Jackman and Moose River Plt. will become the responsibility of School Administrative No. 12; and

Whereas, a 55% increase in enrollment of the district will create severe financial hardships; and Whereas, the time for raising money at budget meeting or town meetings is already passed; and

Whereas, the following legislation becomes essential; and

Whereas, in the judgement of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

General purpose aid for School Administrative District No. 12. The computa-tion of general purpose aid for School Administrative District No. 12, notwith-standing any other provision of the Revised Statutes, Title 20, shall be ac-complished in accordance with the following:

Subsidy computation. All pupils resident of Jackman or Moose River Plt., who have been attending Sacred Heart Academy or St. Anthony Elementary School shall be counted in the subsidy computation as though they had been attending public schools during the last biennium.

2. Allowable expenditures. For the purposes of this subsidy computation, the allowable expenditures for the students in Sacred Heart Academy and St. Anthony Elementary School shall be the state average expenditure during the 2-year period involved.

3. 1969-1970 biennium. For all subsidy computation purposes in the 1969-1970 biennium, the pupils now attending Sacred Heart Academy and St. Anthony Elementary School shall be counted in the computation of aid for School Ad-ministrative District No. 12, and the average per pupil expenditure of the State shall be used as the expenditure for these pupils during the period when they were not in the public school.

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.
