NCCA Board of Trustees Meeting

Judith McGann called the meeting to order at 8:01 am. Introductions were made of all present. Jean Adie, Data Clerk introduced herself to the board.

<u>Financials</u>

Lisa presented the 2023-2024 Proposed Tuition Rates at a 5% increase Committed Slot: \$6,628.13 Additional Slot: \$7,911.33 Vermont/: \$16,979.55 (Non-Committed)

Marion Anastasi made a motion to approve the rates at a 5% increase, Troy Merner seconded the motion. **Board unanimously approved.**

Lisa gave a brief history of NCCA's slot commitments. Lisa would like to modify the definition of the additional slot. In order to get an additional slot at a rate of \$7,911.33, or buy/sell committed slots for the FY24, you must first commit to at least 1 slot for the year. If you do not commit to at least 1 slot for the year, and end up needing one, regardless of your district, the school would need to buy a slot at the same rate as the Vermont(Non-Committed) rate of \$16,979.55. Georgia Caron made a motion to accept this agreement and Jay Dugan-Henriksen seconded. **Board unanimously approved.**

Lisa reviewed the FY23 Budget and mentioned some notables so far this year, such as slot revenue up so far by about \$46,000, (\$31,000 already received and \$15,000 unbilled at time of

meeting), NHUC rates down 0.5% and looking into FY24, NHRS rates will decrease 1.38%, Health Trust GMR 17.9% increase.

Fund balances were reviewed and NCCA's investment account will be reviewed in January with our Raymond James Investment Advisor, Thomas Brussard.

Georgia Caron made a motion to approve Proposal #4, Rebecca Metcalf seconded the motion. **Board unanimously approved.**

Jay Dugan-Henriksen made a motion to table Proposal #5 until November board meeting, Troy Merner seconded. **Board unanimously approved.**

Superintendent's Report

- Lisa sent out a letter to all parents to garner up interest for our parent board member openings and if interested to let her know by November 1st.
- Lisa reviewed current enrollments, 17 Littleton, 29 Lancaster. 4 dismissals so far this year, 2 for threatening behavior and 2 volunteered to withdraw to homeschool.
- AT&T awarded us a \$10,000 grant. It will be used for a video project with the students.
- Looking ahead to a 20th Anniversary celebration in the fall of 2023. Potential to rebrand and redesign our school and its logo.

- Lisa applied for and was awarded a \$20,000 grant from the Neil & Louise Tillotson Foundation.
- NCCA did a field trip to Casella Waste Management. Rebecca commented that it went well and the kids got to see how many potential careers there were in the industry.
