BOARD OF EDUCATION SOUTHERN LOCAL SCHOOL DISTRICT COLUMBIANA, CARROLL AND JEFFERSON COUNTIES, OHIO

The Board of Education (the "Board") of the Southern Local School District, Columbiana, Carroll and Jefferson Counties, Ohio (the "School District"), met in regular session on June 13, 2023, at 5:30 p.m., at the Jr. Sr. High School Media Center, 38095 State Route 39, Salineville, Ohio 43945, with the following members present:

M____ introduced the following resolution and moved its passage:

RESOLUTION OF NECESSITY TO LEVY A TAX IN EXCESS OF THE TEN-MILL LIMITATION

Permanent Improvement Levy (Ohio Revised Code Sections 5705.03, 5705.21, and 5705.25)

WHEREAS, the amount of taxes which may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the School District; and

WHEREAS, a resolution declaring the necessity of levying a tax outside the ten-mill limitation must be passed and certified to the County Auditor of Columbiana County, Ohio (the "County Auditor") in order to permit the Board to consider the levy of such a tax, and must request that the County Auditor certify to the Board the current total taxable value of the School District, the estimated property tax revenue (rounded to the nearest \$1,000) that will be produced by such tax based on such total taxable value, and the amount of the additional tax, as required by Ohio Revised Code Section 5705.03(B)(2)(c)(ii)) expressed in dollars, rounded to the nearest dollar, for each \$100,000 of the "county auditor's appraised value" (as defined in Ohio Revised Code Section 5705.01(P));

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Southern Local School District, Columbiana, Carroll and Jefferson Counties, Ohio, two-thirds of all of the members thereof concurring, that:

<u>Section 1.</u> It is necessary for the School District to levy a tax in excess of the ten-mill limitation for the purpose of general permanent improvements.

Section 2. As authorized by Ohio Revised Code Section 5705.21, the question of such tax levy (the "Levy") shall be submitted to all of the electors in the entire territory of the School District at the election to be held on November 7, 2023. All of the territory of the School District is located in Columbiana, Carroll and Jefferson Counties, Ohio.

Section 3. The Levy shall be at a rate not exceeding 0.50 mills for each \$1 of taxable value upon the entire territory of the School District for a continuing period of time.

Section 4. The Levy shall include a levy on the tax list and duplicate for the 2023 tax year (commencing in 2023, first due in calendar year 2024), if approved by a majority of the electors voting thereon.

<u>Section 5.</u> The Treasurer of the Board is directed to promptly certify a copy of this Resolution to the County Auditor with instructions to calculate and certify to the Board the current total taxable value of the School District, the estimated property tax revenue that will be produced by the Levy based on such total taxable value, and the amount of the Levy expressed in dollars (rounded to the nearest dollar) for each \$100,000 of the county auditor's appraised value.

<u>Section 6.</u> It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Ohio Revised Code Section 121.22.
