Board Meeting Minutes July 27, 2023

4:00 p.m.

The meeting was called to order at 4:00 p.m. by Mr. Rayvell Smith, President.

Establishment of a quorum.

Members present: Mr. Freddie Charleston, Mrs. Lynda Joiner, Mr. Chester Moore, and Mr. Rayvell Smith.

Member absent: Mr. John McAlpine.

The invocation was given by Mr. Smith.

Approval of Agenda

The motion to approve the agenda was made by Mrs. Joiner and seconded by Mr. Charleston. It carried unanimously.

Second Approval of Previous Meetings

The motion for second approval of the June 22, 2023, Board Meeting Minutes and the July 18, 2023, Board Meeting Minutes was made by Mr. Charleston and seconded by Mrs. Joiner. It carried unanimously.

I, Luke Hallmark, Superintendent of Education of Marengo County Schools, do hereby make the following recommendations:

Business Matters

• Bob Young – Frazer Lanier

Mr. Bob Young with Frazer Lanier spoke to the Board members about the financing of the upcoming HVAC and Sweet Water High School roofing projects. The new funding project will add additional money to the present debt through payments of bonds. The payments will extend out while reducing the payments from \$430,000 a year to \$380,000 a year. Mr. Young will get a rating from Standard and Poors which usually takes about a week. The rate should be locked in during September.

• Richard Johnson – Financial Update

Mr. Richard Johnson, new CSFO, gave the Board members a financial update by PowerPoint. In the General Fund, the cash balance as of May 31, 2023, was \$1,385,124.42. The receipts were \$1,354,855.17 while the expenditures were \$1,957,709.52. This left a June 30, 2023, cash balance of \$782,270.07. This cash balance is less than last month but that is expected this time of year. In comparison to this time last year, it is up a little over \$300,000.

• Wendy Joiner – Instructional Update

Mrs. Wendy Joiner, Instructional Leader, gave a report to the Board members. She gave an ACAP summative update and reported the celebrations at each school. There was a lot of growth throughout the system. It was very noticeable in the 3rd grade Reading and 5th grade Reading scores. The students performing at the proficient level improved by double digits. In Math, the percentage of students proficient increased at all grade levels. Two new Math Coaches have been hired and the first planning meeting will be held on July 31st. The PreK numbers have increased rather slowly. Sweet Water High School is full while A. L. Johnson High School and Marengo High School are looking to add to their enrollment. The MTSS District Alignment Kickoff meeting will be held on September 14, 2023, at the Pelham Civic Center. The meeting will take a look at our district's mission and vision. We have received a \$48,911 School Safety Grant. The money will be used to purchase fencing at A. L. Johnson High School and Marengo High School. The system also received an Anti-Bullying Prevention Project funding of \$33,093 to purchase our Peer Helper Program. Ms. Kenyetta Evans presented at Mega Conference and did a wonderful job. She spoke on mental health issues throughout the schools. A. L. Johnson High School and Sweet Water High School had students that were recognized this summer at different camps. In closing, Mrs. Joiner pointed out all of the PD training that our faculty attended this summer.

Black Warrior Telecommunications Consortium / Utilities Report The Black Warrior Telecommunications Consortium financial statement for June 30, 2023, was \$76,788.06 in the checking account and \$90,410.93 in a CD. The utilities report for June, 2022, was \$30,214.42 while June, 2023, was \$27,337.01

• Whole Board Training / Tax Renewal Update

The Superintendent mentioned that the Whole Board Training would take place in either August or September and the topic would be on Finance. Also mentioned was an update on the tax renewal. A meeting has been held with the Probate Judge and Tax Assessor about the proper steps that need to be made.
