Milk in the milk cooler by serving line was observed to be 43F and this was not right after a lunch service. The gasket was observed to be loose with mold-like substance on it. This cooler was also observed to have water and rust in the bottom and staff stated it had just been cleaned recently. This milk cooler must be repaired or replaced.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.
