He shared that USDA is requiring additional information for the PAR (Preliminary Architectural Report) and from Terracon, who does our Environmental Report. He also shared that the required property appraisal was completed by Mancuso Appraisal Services. He stated that our current property (secondary campus) is valued at \$21,445,000.00. The estimated value of the property after the completion of the gymnasium will be \$28,700,000.00.

NEW BUSINESS

Mr. Johnson shared information about the Safety and Security of School Buildings Grant. He stated that Ridgeview would receive \$20,409.00 from this grant. He shared that the money could be used to purchase cameras for the elementary campus which would meet the requirements of the grant.
