A citizen addressed the board regarding their wish that the board would approve a lawsuit against the former superintendent, and expressed frustration that all that has happened so far is that the former superintendent was fired.

A citizen expressed frustration that the former superintendent was let go without cause, and that the board failed to act in a timely manner.

A citizen spoke of a major discovery, and undisclosed item that could involve the FBI and could shut down the district.

A citizen thanked the new board members for joining the board and said that the former superintendent has been intimidating current and former employees. It was also mentioned that the former superintendent's daughter is still employed at the school and that there have been allegations of drug use on campus.

A former employee spoke of the nepotism of the former superintendent hiring her daughter and that the daughter brings a dog on campus.

An employee mentioned that another employee's dog jumped into another person's car on campus.

Peggy McConnaughy said she had heard a lot of what was being mentioned for years, but that as a board member she has to follow the Brown Act. She acknowledged the allegations and said she would do the best she could to work on the situation.

She mentioned she was also concerned that the former superintendent's daughter was employed at the school, but there were procedures that need to be followed and that things need to be dealt with one at a time.
