### **Engagement Plan**

Teachers at PBHS are required to enter two grades per week in e-school as well as communicate with parents through email and/or phone when problems arise.

The PTO will be instrumental in getting information/announcements to parents and the community via social media.

Pine Bluff High School has formed a Customer Service committee to improve parental and community engagement by working more closely with parents and the community through communication, workshops, and other engaging activities with PTO.

Pine Bluff High School will provide reports to parents every four and a half weeks with information regarding their child's academic progress and upcoming classroom and school events.

Teachers will send home grade reports, and parents can access their child's grades via e-school or HAC software. Parents will receive HAC information through the Media Center.
