6. Public Comments on Agenda Items

The citizen then made reference to the salary which he received at his prior school corporation and inquired about the salary he would be receiving at Tri-Township CSC.

The same individual asked if the treasurer and deputy treasurer positions were advertised. Mr. Shepherd indicated that yes they were advertised and that there was one applicant for the positions. When asked why this was added to the agenda late Mr. Shepherd indicated that he has been very busy and just had not had time to finalize the agenda.

The same citizen asked if any current funds will be used for the upcoming building project. Superintendent Shepherd indicated no, current funds would not be used.

7. Tiger Den Roof Scan with TREMCO-information

Superintendent Shepherd advised the board that the barrel roof above the gym is 100% dry. There was a small wet spot on the back of the roof that was repaired during the scanning process. A detailed assessment will be out in about a week. At that point we can discuss more in depth our desire for an on-going roof maintenance service agreement with TREMCO to maximize the life span of our roofing.

8. <u>Go Guardian</u>

The Go Guardian program will allow each teacher to monitor exactly what each student is doing on their device throughout the day. This benefits the corporation both in the classroom and for distance learning.

9. Gym Floor Updates-information

Creekview Flooring will again refinish the floors this summer July 14-16. Next year we are on the calendar for Foster Flooring to completely strip, sand, and repaint both of our floors.

10. <u>Field Trip Policy</u>

This is the second reading for this policy update. The major change involves the elimination for overnight trips for our 8th grade and senior trips. 11. <u>Continuing Disclosure (Debt) Monitoring Contract-</u> information

Superintendent Shepherd has asked Ice Miller to provide a quote to monitor and update our yearly obligations of continuing disclosures for any debt.

12. ESSER III Plan w/ public comment- information

Mr. Shepherd explains that the ESSER III funds total a little over \$400,000. Our first priority for these funds will be to mitigate learning loss for our students. We will be offering a more robust summer school program along with after school tutoring for our students. Professional development for our staff will take place as well. Special emphasis will be made to reach our struggling learners which will be identified via learning assessments. 20% of this grant must be set aside for evidence based learning loss. Other priorities may still remain such as social distancing and our plan for in person learning. We will continue to follow state and CDC recommendations for our plan.

A concerned citizen asked if we have any plans to use any ESSER III funds for capital projects of any kind. Superintendent Shepherd said plans no but is that a possibility yes. The same citizen also asked if any of the ESSER III funds will be used for pay raises for teachers. Superintendent Shepherd explained that there are no plans for that. He wants our teacher raises to be sustainable.

13. <u>Principal Reports</u>

Principal Gabriel expressed that Wanatah ended the year strong. This year has been challenging but he is very proud of our students, staff and Tiger families

Summer school started on 06/07/21. We are already planning for next school year!

Principal McMahan explained that we have 15 high school students enrolled in summer school who are able to get 12 credits during the summer. We are offering English, math and speech this summer.

Academic and athletic awards went very well at the end of the school year. Prom was the night before graduation on our last day of school. It was a nice venue which we are looking at for next year as well. Graduation was a success! A big thank you to our staff, students and families for helping us to make this challenging year successful!
