The purpose of this letter is to let you know that Lake Wales Charter Schools will provide information to you regarding your child's teacher and paraprofessional qualifications in a timely manner upon request.

Federal law allows you to obtain certain information about your child's classroom teacher(s) and instructional assistants, and paraprofessionals.

You have the right to request the following:

- The teacher's Florida certification area(s) and,
 - If the teacher is teaching infield or is qualified according to Lake Wales Charter Schools.
 - If the teacher has met state licensing criteria for the grade levels and subject areas in which the teacher provides instruction.
 - If the teacher is teaching under temporary, emergency, or other provisional status OR has been teaching for less than four years.
 - If a teacher has received a summative performance evaluation rating of unsatisfactory per s. 1012.34, F.S., Personnel evaluation procedures and criteria.
- The instructional qualifications of any instructional paraprofessional who provides services to your child.

You will be notified in writing if your child has been assigned or has been taught four consecutive weeks or more by a teacher who does not meet applicable State certification or licensure requirements at the grade level and subject area in which the teacher has been assigned [ESSA 1111(g)(1)(B), 1111(h)(5)(D), and 1112(e)(1)(B)(ii)]. The information regarding the qualifications of your child's teacher and/or classroom paraprofessionals may be obtained from your child's principal.

In addition, your child's school will provide information on the level of achievement of your child on state academic assessments. This information will be available at your child's school.

Please be assured that Lake Wales Charter Schools is dedicated to providing your child(ren) a quality education. If you would like to receive any of this information, please contact your child's school.

Usted tiene derecho a solicitar la siguiente información:

- Materias en la que el maestro este certificado en la Florida,
 - Si el maestro enseña en el área que este certificado o si está capacitado según las políticas de Lake Wales Charter Schools.
 - Si el maestro cumple con los criterios del estado para la licencia de maestro en la materia que enseña.
 - Si el maestro tiene una certificación temporal o provisional o si lleva enseñando menos de 4 años.
 - Si el maestro recibió una evaluación insatisfactoria basada en s. 1012.34, F.S., Personnel evaluation procedures and criteria.
- La preparación profesional de cualquier auxiliar docente que sirve a su hijo(a).

Se le notificará por escrito si a su hijo(a) se le ha asignado o se le ha enseñado por cuatro semanas consecutivas o más por un maestro que no cumple con los requisitos de certificación o licencia estatal aplicables en el nivel de grado y la materia en la que el maestro ha sido asignado [ESSA 1111(g)(1)(B), 1111(h)(5)(D) y 1112(e)(1)(B)(ii)]. La información sobre las calificaciones del maestro y/o del salón de clases de su hijo los para-profesionales se pueden obtener del principal de la escuela de su hijo(a).

Además, la escuela de su hijo(a) proporcionará información sobre el nivel de logro de su hijo en las evaluaciones académicas estatales. Esta información estará disponible en la escuela de su hijo(a)
