The Fannin County Board of Education met in a called meeting with the following members present: Chad Galloway, Chair; Terry Bramlett, Vice-Chair; Bobby Bearden; and Lewis DeWeese. Mike Cole was absent. A quorum was met. The meeting was held at the Fannin County High School (FCHS) Performing Arts Center (PAC) to allow for adequate social distancing due to concerns with COVID-19.

The meeting was called to order by Chad Galloway, Chair.

Motion by Terry Bramlett, seconded by Bobby Bearden, to approve the paving of the East Fannin Elementary School parking lot and bus pad by Johnson Paving for \$63,407.88. The quote includes 1,750 square yards of asphalt being removed and replaced with 2" asphalt, and 2,906 square yards of 1.5" overlay to be paid with SPLOST funds. **(See attached.)**
