Annual School Budget Vote and Board Elections

The Hadley-Luzerne Central School District Board of Education is proposing a budget of \$24,202,479 for the 2024-25 school year resulting in an estimated 1.9% increase in the tax levy, which is well below the tax levy cap of 3.67%. This represents an overall budget-to-budget increase of \$908,584 or 3.67%, which will be offset by use of the district's fund balance and cost-saving measures.

Each year, our school district strives to provide an academic program that supports a safe, positive, and rewarding learning experience. As we developed the 2024-25 budget, our goals were to maintain programs, maximize taxpayer dollars, and keep budget increases to a minimum. We are pleased to say we have been able to achieve these goals.

For the 2024-25 school year, the district will continue to provide primary care health services to students on campus through our partnership with Hudson Headwaters. Having this provider on-site allows students to attend school consistently and receive the services they need while learning and playing alongside their peers.

When crafting the budget, the district examined expenditures line-by-line to identify cost-saving measures. Some BOCES services have been reduced for next year, along with some clinical counseling services through an outside service provider. We have switched to paperless systems for report cards and arrival/dismissal coordination, and two positions that will be vacated due to retirement will remain unfilled. Some of the services that BOCES provided will be brought in-house next year to better meet the needs of our students.

At the same time, the district is using \$1 million from the Fund Balance and Reserves to fill the gap between revenue and projected expenditures. We are mindful of using savings to balance the budget, which is why we are so careful with our spending.

NYS Education Law allows school districts to conduct one \$100,000 "capital outlay" project per year, which does not require special approval from voters. Capital outlay projects are reimbursed in the form of revenue (based on the district's NYS Building Aid ratio) the following fiscal year. The capital outlay planned for next year will repair the roofs over the Large Group Instruction space at Stuart M. Townsend Elementary School and the cafeteria at the Junior/Senior High School.

We are proud of the educational opportunities we are able to provide our students while being fiscally responsible to the taxpayers. We appreciate the support and partnership of the PTSA, Booster Club, and residents who entrust us with their children and their investment in our facilities.

ON THE BALLOT

2024-25 Proposed School Budget

RESOLVED, to adopt the annual budget for the 2024-2025 school year in the amount of \$24,202,479 and to authorize the requisite portion therefore to be raised by taxation on the taxable property of the district.

Proposition 1

RESOLVED, that the Board of Education is hereby authorized to acquire one (1) 66-passenger school bus and two (2) 22-passenger handicap accessible school buses at a maximum estimated cost not to exceed \$456,500, which is estimated to be the maximum cost thereof, and to expend such sum for such purpose and to levy the necessary tax therefore taking into account state aid received, to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, issue bonds and notes of the district at one time or from time to time in the principal amount not to exceed \$456,500 and to levy a tax to pay the interest on such obligations when due.

Election of Two School Board Members

Vote to elect two (2) members to the Board of Education, at large, to three (3) year terms commencing on July 1, 2024 and expiring on June 30, 2027. The incumbents are Justin Hunt and Shana Graham, whose terms expire on June 30, 2024.

BASIC STAR EXEMPTION IMPACT

Election of Library Trustees

Vote to elect FOUR (4) members to the Board of Trustees of the Rockwell Falls Public Library, at large. Two to three (3) year terms, commencing on July 1, 2024 and expiring on June 30, 2027 and two one (1) year terms commencing on July 1, 2024 and expiring on June 30, 2025. The two candidates with the highest votes will fill the two three-year terms, and the third and fourth highest votes will fill the one-year terms.

Why Are We Voting for Library Trustees?

In June 2019, voters approved the Hadley Luzerne Public Library's request to change its charter from a "municipal library" – funded only by the towns of Hadley and Lake Luzerne – to a "school district library" that would expand the tax base to the same geographical area as the Hadley-Luzerne Central School District. The vote was 241 votes for and 199 against.

"School District Public Libraries" are totally independent of the school district. They are corporate entities chartered by the Board of Regents and registered by the Commissioner of Education. NYS Education Law provides a means for public and association libraries to access voters in the community in order to levy taxes and to use tax collection mechanisms. Tax money collected for the library is kept separate from the school district budget, and any increases to the library budget would face approval by popular vote of school district constituents. The library board of trustees are elected to three-year terms rather than appointed.
