The Randolph County Board of Education met in a work session on Monday, October 19, 2015 at 4:30 p.m. in the Central Services Boardroom, located at the 2222 South Fayetteville Street Office in Asheboro. Finance & Budget Division

1. Quarterly budget update

Finance Officer Todd Lowe presented the first quarter budget update including the following:

1. Quarterly student assignment update

Marty Trotter, Assistant Superintendent for Operations presented the first quarter student assignment update.

- 2. Alternative education option for students who are long-term suspended

Marty Trotter presented an alternative education option for students who are long-term suspended. The plan applies to students (high school, middle school, or elementary school) who are removed from their classes and are not eligible for In-School Suspension (ISS), Intervention Center (IC), or Intervention Center Aggression Replacement Training (ICART). It was also noted that the plan does not apply to students in the Exceptional Children's Program.

3. Change in elementary school standards regarding bus drop-off procedures

Marty Trotter shared information regarding elementary school drop-off procedures. The Randolph County School System has followed a no drop-off procedure for bus riders in grades K-5 unless the driver could verify the parent is at home. The Department of Social Services uses the following "Community Standards" when determining proper supervision of children:

- Children 6-8 years of age are not to be left alone for more than a few minutes
- Children 9-10 years of age are not to be left alone for more than two hours
- Children 11-12 years of age are not to be left alone for more than four hours

Mr. Trotter shared that most of the school systems in our surrounding area use a no drop-off procedure for bus riders in grades K-3 and allow students in grades 4-5 to be dropped off regardless if a parent is home or not. The Randolph County School System is interested in adopting a similar procedure for bus riders with parental consent. The board had discussion regarding the requests in writing being notarized and also including information for inclement weather/early dismissal.

Superintendent's Office

1. Overview of upcoming Board of Education and staff events/issues

The superintendent presented an overview of upcoming events. November 23 will be a work session with the legislators and January 11 will be a work session with the county commissioners. The Board of Education meeting in March will be on Wednesday, March 16 due to AdvancED.
