myON provides a personalized digital library for each student and can be used for intervention and remediation. Teachers ensure grade level COS alignment by assigning students appropriate reading tasks and monitoring them. The library is available 24/7, at school and home, online and offline. myON offers close-reading tools, recorded audio, and a built-in directory and manipulatives.

Almsweb Plus enable Plke County Schools to offer continuity in assessing students above third grade. Aimsweb Plus screens and monitors the reading and math skills through 12th grade. Plke County uses the program through 8th grade. Aimsweb Plus also has add-on screeners for behavior and dyslexia (grades 4-8) for a comprehensive, all-in-one system.

Rosetta Stone helps remote students continue to acquire English language. It personalized language learning through an adaptive model, while incorporating scaffolding instruction and speech recognition technology. Individualized learning paths help students to take ownership of their own language development. It is available 24/7 at school and home, online.

Parents are able to access current information on school and systems websites. They can sign up for electronic notifications/reminders of school events and activities through the "Notify Me" system on each school's webpage. They can also elect to have the notices sent to email accounts or as a text message. The School Messenger system is used to contact parents in emergency and system-wide notification situations. In addition, parents may download the Pike County Schools app on Apple and Android devices and/or follow Pike County Schools on Twitter and Facebook.

Targeted students in grades 7-12 will participate in before and after school tutoring beginning Fall 2021. They will have an opportunity to receive intervention in classes in which they are currently enrolled. Tutoring will take place after school, in what we call 5th block, from 3:30-5:00 p.m.; or before school (0 block), beginning at 6:45 AM. Both will be 3-5 days per week. Transportation and snacks will be provided. Teachers selected for tutoring will be those who have demonstrated an ability to improve student performance. School administrators will oversee the tutoring program.

Targeted students in grade K-3 will participate in after school tutoring beginning Fall 2021. They will have an opportunity to improve reading skills through varied instructional approaches. Teacher-led, direct, explicit systematic reading intervention will be provided using a SDE approved program. Tutoring will take place 3:30-5:00 p.m., 3 days per week. Transportation and snacks will be provided. Teachers selected for tutoring will be those who have demonstrated an ability to improve student performance. School administrators will oversee the after school tutoring program.

Pike County Schools conducts routine surveys to assess educational needs. Two surveys have been conducted to determine the technological needs of students. Two surveys have been conducted to determine the professional learning needs of teachers. In addition, an informal internal needs assessment was conducted on Pike County Schools' initial response to the pandemic. Information gathered was used to determine Pike County's implementation plan. Impact for effectiveness of purchases will be determined by proficiency recorded in student achievement data.
