Finance Committee - Carolyn

- Contract with Dieci is expiring on June 30, 2025. After discussing during the finance committee meeting, Alyssa, and Chris, the recommendation is to renew the contract.
- Only concern is timeliness. Chris and Joe have been working on some systems so that items arrive more timely for the Finance Committee meeting. Joe is aware of this and working to improve it.
- Dieci is not expanding and is focusing on giving current clients more personalized services the latest contract was more detailed and explicit about services offered. They are working on hiring and that is difficult in current job market.
- Joe has good connections with other service providers as well.
- They are really on top of things. They know us well and we trust their work. We have confidence in their numbers, and they are very conscientious. The current good working relationship is invaluable.
- Every three years we have to put out a call for bids; this year we put it on the website. We could have more widely published, solicited bids, but we did put it out there. Dieci was our only bid.

- Some discussion about division of labor between Joe and Chris/school. Processes getting less burdensome and more efficient. If there's more that would be helpful to do, the board would be willing to discuss more.
- Joe's value add is not simply the monthly work but in his extensive knowledge of the MDE systems and applications, etc
- Moving toward using <u>bill.com</u> to track and pay bills but not there yet. Discussion of complications of technology and good questions as we transition to new systems.
