**Special Meeting - Wednesday, July 27, 2022**

The Stark County Community Unit School District #100 Board of Education met in special session on Wednesday, July 27, 2022, at Stark County Elementary School. Members present were Matthew Nagode, Ann Orwig, Erin Price, Brian Rewerts, David Steward and Bruce West. Also present were Brett Elliott, Superintendent. Emily Holman was absent.

With a quorum present, the meeting was called to order by President, Mrs. Orwig, at 5:31 p.m.

There were no public comments.

Mr. Elliott explained that the Consolidated District Plan is a grant summary of all state and federal grants received each year and our plan for expenditures. Since the original BOE approval, the most significant change has been the change regarding Title IV funds. Instead of transferring to Title I, Part A, now we are using them to pay a portion of the dual-credit tuition costs for students taking classes at BHE. We have also included the IL-EMPOWER grant information for the Jr. High School Improvement grant. 
