Esteem is a school-based program that covers Senate Bill 9 for grades 5th-12th.

- Based out of Longview.
- Cover all TEAKS but 2, doesn't cover CPR and Health and Nutrition TEAKS
- Each lesson builds on previous lessons
- Would have a specific educator from Mercy Manor assigned to our school to assist.
- Program is free – no cost to Frankston due to a state grant. (Due to the grant, an anonymous survey would have to be completed and attendance would need to be taken)
- Nurses, counselor, or teachers can teach the program.
- 10 lessons that take approximately 3 months.

Next Implementation steps:

- Hold 2 public meetings for parents and community members to review materials.
- School board adoption of the program
- Memo of Understanding with Mercy Manor
- Certification Training (1 Day)
- Parent/Guardian Permission forms. It is a opt in program so parents will have to consent.
- Parent preview night.
- Begin lessons at school (Could be during PE, Health, or any elective class)
