Notes to Enumerators—

- Section 4007 as amended in 1905 provides for the taking of the school census.
- Enumerators shall not include in the census the names of any child or children in reformatories or prisons, nor the names of any child or children in asylums, almshouses, or other charitable institutions, except as provided in Section 4007 of the Public Schools Act of 1905.
- Children in such institutions who regularly attend the public schools.
- The children of the parents of the child or children in such institutions as provided in Section 4007 of the Public Schools Act of 1905.
- Enumerators shall not include in the census the names of any child or children in reformatories or prisons, nor the names of any child or children in asylums, almshouses, or other charitable institutions, except as provided in Section 4007 of the Public Schools Act of 1905.
- Section 4007 provides for the taking of the school census during the twenty days prior to June 1, 1913. If a child remains from the district during the twenty days preceding June 1, he must be certified in the district in which he is residing June 1.
