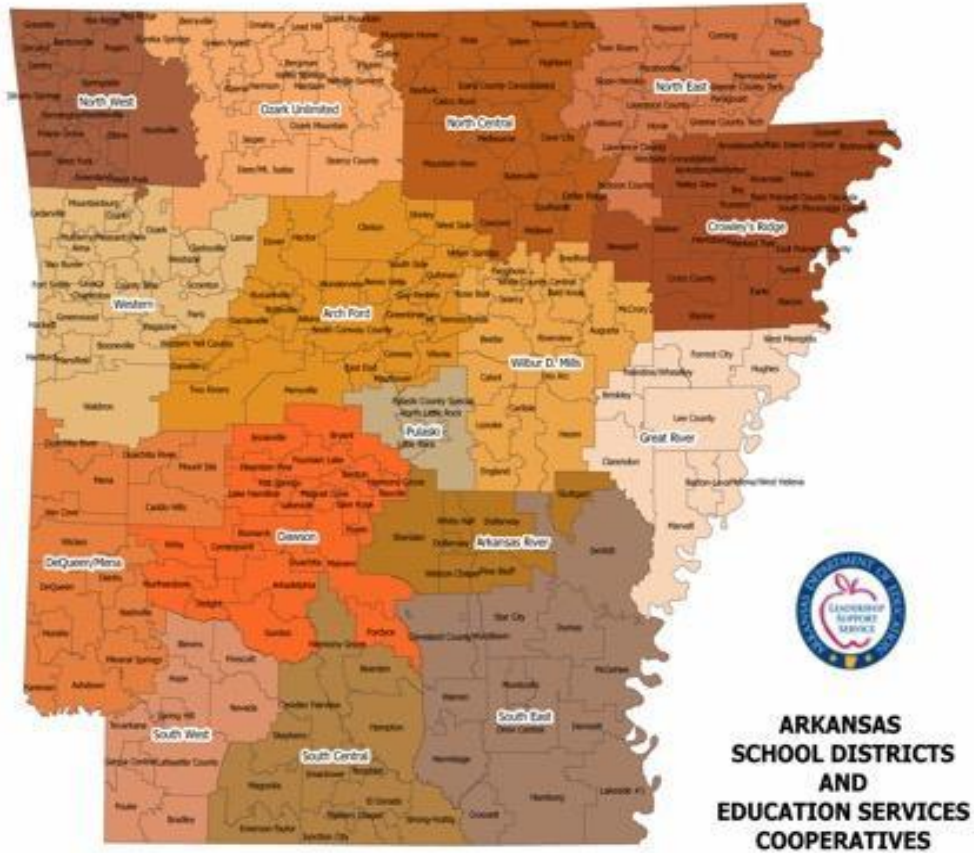
The Southwest Arkansas Education Service Cooperative (SWAEC) is made up of nine school districts in rural southwest Arkansas. The counties we serve include Hempstead, Lafayette, Miller, and Nevada. We serve approximately 11,000 students and 900 public school teachers and administrators. The Co-op offices are located on the campus of the University of Arkansas Hope-Texarkana (UAHT). Our current facility opened in August 2010 through a partnership with SWAEC, UAHT, the City of Hope and the US Department of Agriculture, Rural Development Program.

SWAEC has worked to form partnerships with the Arkansas Department of Education and higher education for the purpose of benefiting our districts. Some of our services include: preschool programs for 3-5 year olds; special education services including education examiner, vision and behavior support; content specialist in math, literacy, science, and technology; career and technical assistance; gifted/talented services; support for novice teachers; bulk purchasing and printing services; professional development; and early childhood behavior assistance. We are actively involved with Henderson State University, Southern Arkansas University, and UAHT. We also work with several community coalitions, such as United Way, Kiwanis and Southwest AR Arts Council, to improve education for our children in southwest Arkansas.

We are pleased to share this annual report. The following reports and program summaries will provide insight to the vast array of programs and services provided to our member schools. We look forward to our continued partnership with our member districts as we serve students and educators in the evolving work of Pre K - 12 education.

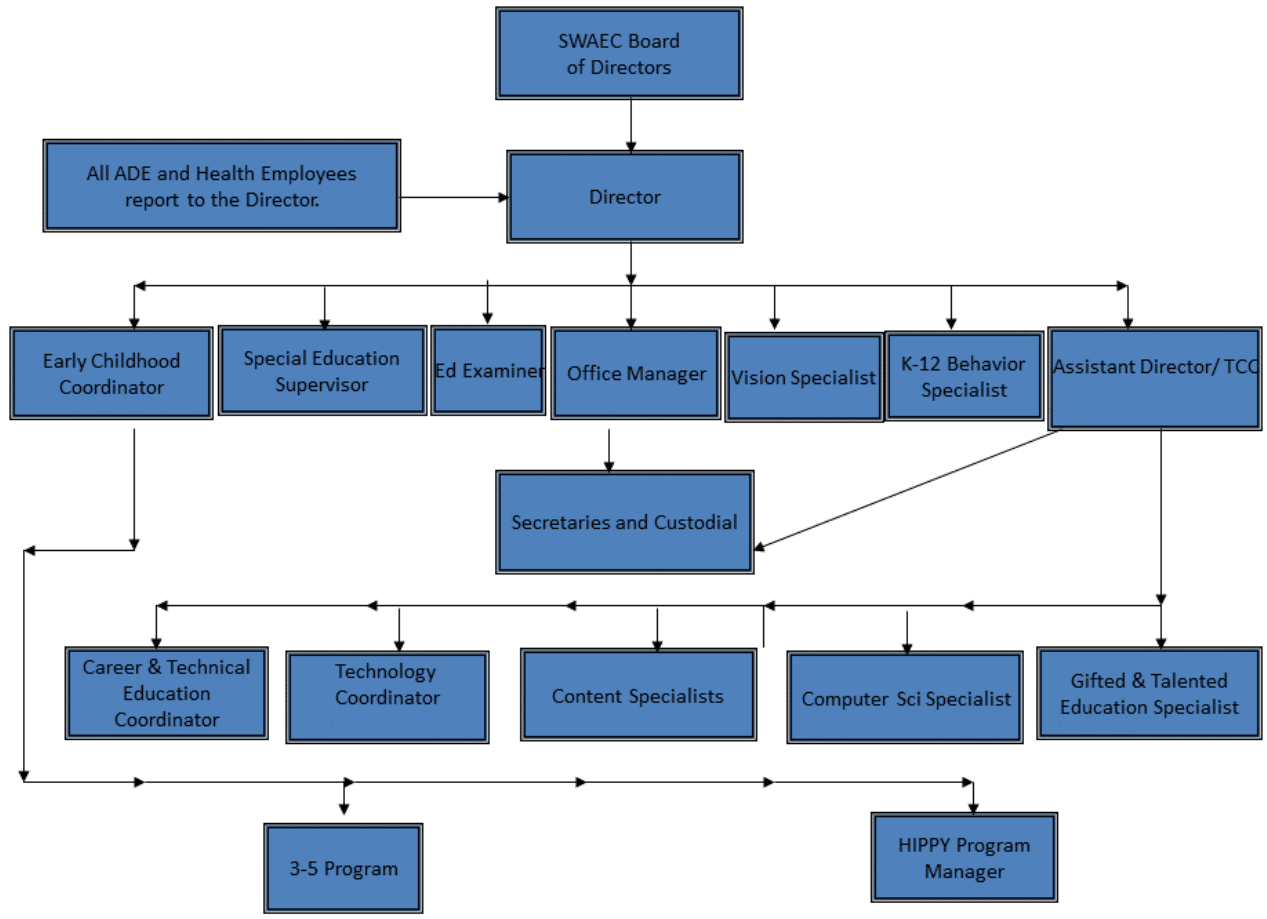

* SWAEC is a strong component of the department's alternate teaching program. We run the fiscal side for four sites and host our own year 1 and year 2 APPEL program. We graduated 14 teachers this April!

* SWAEC has worked with the AR School Board Association and APSRC to provide training specifically for the boards of SWAEC member districts. These meetings allow us to provide more targeted service for the needs of our area boards and allows them to save on travel as they do not have to go to Little Rock for their required hours.

Program Summary:

This grant is designed to provide additional support to students in grades 7-12 in preparing for the ACT. Many students lost valuable instructional time during the pandemic, causing them to perform lower on the ACT. During the pandemic, the ACT was not given as often as in a nonpandemic year. Research proves that the more a student is exposed to the ACT the better they perform.

This program allows for all districts in Arkansas to opt-in for additional support for their students in taking the ACT. The support is intended to be implemented school-wide, allowing all students access and resources to improve ACT scores. The increased ACT scores could lead to additional financial and educational benefits for the students.

There were 261 school districts across the state that opted-in to OnToCollege. This program can be used at the school level in multiple ways. Schools are able to use this resource as a class during the school day, an afterschool program or a summer bootcamp. Training was provided to each district and the program will be provided for two years.

Chad Cargill provided six sessions for 522 students across the state. Each student spent three hours in a live session with Chad Cargill working on strategies for taking the ACT as well as content review. Chad has written a book with all of his tips and strategies and every student received a copy of the book to study further.

Cantrell and Waller Preparatory (CW Prep) is providing 16 sessions across the state to almost 400 students. In these sessions, students spend six hours studying content from the ACT. CW Prep also shares strategies with students when taking the test. Students leave the training with a one-year log-in to all the resources that were shared so they can use them to continue studying for the ACT.

Program Summary:

The Arkansas Professional Educator Pathway (ArPEP), is an affordable two-year, work-based, alternative certification program that is administered by the Division of Elementary and Secondary Education. Enrollment in this program allows a candidate with a bachelor's degree or higher to be licensed and employed as a classroom teacher while completing the necessary requirements for a Standard Arkansas Teaching License. ArPEP's goal is to prepare day one ready teachers to meet the growing demand of the teacher pipeline in Arkansas. The primary objective of ArPEP is to train future educators on how to:

- *build classroom communities
- *design effective lesson plans
- *implement evidence-based instructional strategies, and
- *use assessments to facilitate student learning

SWAEC supported 24 ArPEP students during the 2022-2023 school year from 7 of our 9 districts.

Arkansas Better Chance (ABC) program is a high quality program that serves children, ages birth to five, with a variety of risk factors. However, the majority of availability is for three and four-year-old children. Providers are selected for their ability to offer a high-quality program. These abilities are assessed annually by early education professionals who evaluate each child and their ability for school readiness. The goal of Arkansas Better Chance classroom is to empower children with the skills needed to prepare them for kindergarten.

Program Summary:

ABC Classroom (Arkansas Better Chance) is a center-based school readiness program for families of 3, 4, and some 5-year-olds. ABC staff consists of a trained coordinator, lead teacher, and a paraprofessional. The staff administered the Brigance Developmental Screening and Assessment to each child. Parents receive two parent/teacher conferences throughout the school year to discuss their child's development. The staff is involved in collecting and documenting information on each child for the purpose of entering data into the State Data System Work Sampling. ABC classroom can serve a total of 30 families per year.

Major Highlights of the Year:

- * Every student received a preschool workbook, 2 children's books, crayons, scissors, paint, and pencils to take home for the summer to continue kindergarten readiness learning.
- * Eight students were identified and referred for services with Early Childhood 3-5 Special Education. The students received services to include speech, behavioral, cognitive, PT, and OT.
- * Arkansas Children's Week was full of fun and learning activities.

PROGRAM SUMMARY:

The Arkansas Behavior Support Specialists (BSS) affiliated with the Arkansas Department of Elementary and Secondary Education (DESE) - Office of Special Education lead the state-wide initiative, the BX3 (Behavior eXtreme 3 - Training, Coaching, Empowering) Project. This BX3 project is designed to build capacity by providing coaching to building-level behavior teams that are working to develop tiered systems of positive behavior supports for all students. BX3 assists building level teams in developing and monitoring at least one SMART goal based on their assessment on the Tiered Fidelity Inventory (TFI). Additionally, the BX3 teams create and update an action plan focused on meeting their individualized SMART goal(s). The BSS offer at least 6 coaching sessions (one per month) for each BX3 team. Professional learning opportunities are offered as needed, based on the SMART goal(s) and action plan.

MAJOR HIGHLIGHTS OF 2022-23:

Accepted Cohort 3 with 20 building-level teams across the state

97% of participants in Cohort 3 agreed to strongly agreed that the coaching session on the topic covered was beneficial.

96% of participants in Cohort 3 agreed to strongly agreed that the BX3 Coaches helped their team plan action steps toward meeting our SMART goal(s).

98% of participants in Cohort 3 agreed to strongly agreed that the interactions with and methods used by BX3 coaches were positive and acceptable.

94% of participants in Cohort 3 agreed to strongly agreed that they feel confident in carrying out the steps in their action plan.

CIRCUIT

GOAL:

To provide technical assistance and support to local school district administrators and school personnel in the development and implementation of evidence-based behavior supports for students receiving special education services

To provide technical assistance and support to local school personnel in the identification and educational programming for students identified with autism

To provide professional development to local school district administrators and personnel on evidence-based behavior supports

PROGRAM SUMMARY:

The Behavior Support Specialist (BSS) provides technical assistance in the area of behavior to all school districts within the state. The BSS receives requests for technical assistance through the CIRCUIT on-line referral system. Once a request for services is received, the BSS works in conjunction with the Special Education Supervisor for the referring school district to identify and provide needed support for students with disabilities. Services include:

On-site consultation, student observation, record review and written recommendations with follow up and training as needed

Assistance with Functional Behavior Assessment (FBA) and Behavior Intervention Plan (BIP) development

Assistance with autism identification and programming

Professional development opportunities on evidence-based interventions

MAJOR HIGHLIGHTS OF 2022-2023:

Provided on-site coaching and consultation, student observation, record review, conference attendance, specialized evaluations, assistance with functional behavior assessment, safety and behavior intervention planning for student teams for 148 CIRCUIT referrals across all Education Service Cooperatives

Goal:

The goal of Career & Technical Education is to carry out the guidelines of the 2019 Perkins V Act. This federally funded program is for secondary and postsecondary career education programs to increase accountability and to emphasize student achievement strengthening opportunities for students. The Perkins funding is overseen by the Arkansas Division of Career & Technical Education. Another goal is to better prepare students for the workforce, postsecondary, and military. Based on data gathered from the consortia, a target for the eight Perkins indicators is provided to achieve academic attainment in literacy, science, and math, 4-year and extended graduation rates, post secondary placement, non-traditional participation, non-traditional program concentration, and program quality-attained post secondary credential.

Program Summary:

The CTE Coordinator for Southwest Arkansas Education Cooperative Perkins Consortium is required to write an annual Perkins application determining how to distribute/spend the funding for our area schools based on the indicator goals approved by the Arkansas Department of Career & Technical Education. Stakeholder Meeting, Comprehensive Local Needs Assessment, Start-up Applications, Concentrator Reports, Placement Reports, Certification Reports, Technical Assistance, CTE Enrichment Activities for Students, and professional development are also planned and provided by this office.

Major Highlights of the Year:

Throughout the year, SWAEC CTE Coordinator continued work on the Miller & Hempstead County ACT Work Ready Community teams. ACT Work Ready Community teams help promote WorkKeys and NCRC certifications and recognition and recommendation of the NCRC to attract business and industry to the area to promote economic development and growth. All of the counties SWAEC serves (Hempstead, Miller, Nevada, and Lafayette) have met more than 70% of their goals to become ACT Work Ready Certified Communities. These teams will also implement a plan to recognize students with high scores on the NCRC through lapel pins to be awarded at graduation.

The CTE Coordinator hosted a New CTE Teacher In-service where new teachers were introduced to Perkins, CTSOs, DCTE, and certifications, among other information that is essential to becoming an effective CTE Teacher.

The SWAEC CTE Coordinator hosted Regional Hybrid/Virtual PLCs for FCS, Agriculture, and Business teachers in the summers to support CTE teachers in their occupational areas and allow them to network with others in their content areas across Southwest AR.

The CTE Coordinator presented with the DMESC and SCSC CTE Coordinators to present their partnership on non-traditional student events to other AR Education Cooperatives' CTE Coordinators in the Fall CTE Coordinators Perkins Meeting at the request of DCTE during October.

The SWAEC CTE Coordinator hosted WorkKeys Support Zooms once a month for districts needing support.

SWAEC CTE Perkins Consortia received a combined \$495,995.66 in additional funding through grants written by the CTE Coordinator for New CTE Program Start-up Grants, DCTE Non-Traditional Grant funding, and DCTE Innovation Grant funding to build and enhance new CTE programs, remove barriers to obtaining a driver's license, which is essential to working, expose students to careers in our area, and teach students new skills related to in-demand fields in our local workforce through student events.

Through the writing of New CTE Program Start-Up Applications in October, Fouke High School received \$33,0430 for a new CS:Robotics Program of Study; Hope High School received \$24,225 for a new Work Based Learning Program of Study; Lafayette County High School received \$24,225 for a Career Readiness Work Based Learning Program of Study; and Spring Hill High School received \$86,573 for a new Nutrition Science & Dietetics Program of Study. Total for 2023-2024 new CTE Program Start-up Awards for SWAEC schools was \$168,066.

A total of \$144,547.28 was awarded for DCTE Innovation Grants for Prescott High School and Hope High School for the purchase of L3 Driving Simulators to help remove barriers for students attempting a driver's license and CDL. As a result of this grant, AR State Police has reached out to partner with these schools in developing a plan to remove barriers for students who are struggling with obtaining a driver's license.

The CTE Coordinator partnered with DMESC & SCSC CTE Coordinators to procure DCTE NonTraditional funds totalling \$38,082 for the Regional Be A Model, Break the Mold Event. This event is designed to expose 9-12th grade girls to jobs in manufacturing and was held at UA Rich Mountain, UA Cossatot, SAU, and UA Hope/Texarkana and showcased each organization's programs.

The CTE Coordinator partnered again with DMESC & SCSC CTE Coordinators to procure additional DCTE Innovation funds totaling \$145,300 for the Girl Power to the MAX student event. The funds provided Computerized Numerical Control (CNC) BOSS Laser Engravers and CNC Plasma Cutters in every high school in the SWAEC Perkins Consortia. .

The CTE Coordinator also worked on site and via phone with counselors and administrators on scheduling, on new courses, and off cycle start-up applications aligned with new Perkins V requirements for the upcoming year. On-site support for implementation of WorkKeys and Computer Science was provided for districts requesting it. Teachers were supported in planning and administering industry certifications for their approved Programs of Study.

The Southwest Arkansas Regional CTE Showcase allowed Genoa Central CTE Teachers to present their programs and students in March to community and school stakeholders including DCTE SWAEC Area Specialist, Bart Draper, and school board members.

The SWAEC Perkins V Comprehensive Local Needs Assessment Survey was released via Google Form in March 2021 and was revised in June 2022 and again in April 2023 to gather information to guide interpretations of the upcoming Perkins V regulations set to be implemented for Perkins funds in July 2023. The CLNA is a live document that is updated often, as needs arise, and where stakeholders identify needs for our programs.

Goals:

The ADE DESE Office of Computer Science’s established goals and associated tasks for computer science education implementation in Arkansas are divided into five categories:

1. Standards, Curriculum, and Pathways - Successful implementation of computer science education in Arkansas requires the development and periodic revision of a comprehensive and vertically articulated set of K-12 computer science curriculum standards and courses, the local creation of well-developed curriculum that supports student learning, proper alignment of the K-12 expectations and opportunities to industry needs, and appropriate K-20 pathway development for students seeking formal computer science education beyond high-school.

2. Educator Development and Training - Successful implementation of computer science education in Arkansas requires the ADE and its partner organizations to anticipate and address the needs of the Arkansas educational system with regards to knowledgeable and informed computer science teachers. ADE, in collaboration with the Arkansas Educational Cooperatives and other partners, must support quality computer science educator development and training opportunities for all Arkansas Educators and Administrators.

3. Licensure - Successful implementation of computer science education in Arkansas requires the ADE and its partner organizations to anticipate and address the needs of the Arkansas educational system with regards to licensed and endorsed computer science teachers. ADE will continue and further research and implement, when appropriate, flexible licensure pathways and practices, based on legislation and regulation.

4. Outreach and Promotion - Successful implementation of computer science education in Arkansas requires the active use of a broad range of mediums, digital tools, and human networks to properly communicate about the Arkansas Computer Science Education Initiative and respond to the needs and concerns of Arkansas students, educators, community members, and industry leaders.

5. Program Growth and Student Success - Successful implementation of computer science education in Arkansas requires encouraging broad school implementation, supporting lighthouse schools to expand their programs, increasing statewide teacher capacity, growing student interest, and increasing stakeholder interest and support using innovative programs and outreach initiatives.

Program Summary:

Education Service Cooperatives, in partnership with the Arkansas Department of Education, administers the Computer Science Support Program for grades K-12 (Support for Integrating the Embedded K-8 Standards; Middle School Introduction to Coding: Grades 5-8; and High School CS). In the interest of providing Arkansas educators with access to quality computer science (CS) professional development (PD), the Arkansas Department of Education (ADE) Office of Computer Science provided grants for ten Computer Science Specialists beginning in 2017. The computer science specialists each serve the CS PD needs state-wide for all ESCs, and Public School Districts. Assistance is provided to local school district educators through PD services including sessions (ADE developed & customized based on needs assessments) at the Cooperative as well as support on-site in living the mission and striving for the vision of Computer Science Instruction in Arkansas.

Virtual Arkansas had 70 teachers complete the training and assessment and add this endorsement to their license. An additional 18 teacher endorsements are pending.
Deputy Superintendent was a member of the national committee that developed a crosswalk of the National Standards of Quality (NSQ) of Online Teaching and the Charlotte Danielson framework of teaching.
Virtual Arkansas worked through collaborative teams to identify essential standards and realign the curriculum in all courses.
Executive Director served the role of Board President for the Virtual Learning Leadership Alliance (VLLA), a partnership of 20 state virtual programs dedicated to advancing quality online learning.

Goals:

- * Continuing to develop and administer programs to locate, identify, and evaluate three to five -year-old children who are developmentally delayed.
- * Maintaining current information and liaison with other public and private agencies and individuals who provide services to this age population.
- * Through the Local Interagency Council (ICC) and Southwest Bridge Building Committee, collaboration of needs for the southwest are determined.
- * Continuing to develop and administer in-service training for personnel engaged in providing services to the developmentally delayed population, which includes daycares, Arkansas Better Chance (ABC), Head Start, and Day Service Centers in the area.
- * The purpose of the Behavior Interventionist position is to provide behavior support plans and intervention for students with severe behavior (ages 3-5), in all cooperative districts.

Program Summary:

The 3-5 Early Childhood Program takes responsibility for coordinating efforts within the region to develop and establish programs providing special education and related services to identified preschool aged children (3-5 years) with developmental delays; collaborates in planning with the LEAs and superintendents in their districts for implementing activities to ensure the identification of eligible children; provides services to such children in accordance with individual educational plans developed for children with the least restrictive environment being the primary concern. Early Childhood Behavior services are available through the cooperative. Behavior referral procedures are in place at the Southwest Arkansas Education Cooperative through the Arkansas Department of Education ECSpEd website. The Behavior Interventionist has a number of specific duties listed below:

1)Working with parents and agencies when necessary; 2)Writing behavior plans, performing observations, assessments, and referrals; 3) Facilitating manifestation determination conferences; 4)collaborating with mental health providers; 5) conducting parent/teacher consultations; 6)assisting with the management of due process, crisis intervention, identification, etc.; 7)assisting with the management process related to autistic children; and 8)conducting in-service and staff training

For the 2022-2023 year, the Southwest Arkansas Education Cooperative Childhood 3-5 Program has the following data:

At December 1 count, we had a total of 253 children in services, 152 children were screened by SWAEC staff, with many of the screenings being completed at mass screenings for private schools and daycares. In addition, referrals were received from ABC and Head Start programs for children that failed developmental or speech screenings. Referrals were received from parents due to parental concerns.

We had a total of 201 children that needed to be evaluated for services; 147 children transitioned, with 78 being recommended for services in kindergarten and 69 not needing services in kindergarten. For the 2023-2024 school year, we have 120 returning with an additional 20 in the referral and/or placement process.

We provided early childhood behavior support services to 19 children for the 2022-2023 school year. These services included: training and classroom support for general education teachers, setting up and training children and classroom teachers in the use of visual supports and visual schedules, social-emotional support for children, and assisting special education teachers with writing behavior goals and functional behavior assessments.

Goal:

The goal is to provide a resource for assessment and identification of children in 3-5-year-old programs who meet criteria for the state and federal definition of autism spectrum disorder and to assist in the development of educational and behavioral strategies that will offer students a greater opportunity for success in the classroom and community environment.

The Early Childhood Autism Team (A Team) consists of two speech language pathologists, two special education instructors and a behavior specialist. The use of a multidisciplinary approach in the educational diagnosis of autism provides additional validity to the eligibility determination process and provides information from an extended range of perspectives. Determining the qualification of a student under the definition of autism requires information relating to medical, psychological, educational and social characteristics of the student, as well as information regarding the school environment. Students are referred for assessment by parents, classroom teachers, and physicians. A screening instrument, based on the Diagnostic and Statistical Manual of Mental Disorders, Fifth Edition (DSM-V), is completed by the classroom teacher, parent, and at least one member of the team. If the child meets criteria from the screening, specialized evaluation is warranted and scheduled. The team assesses students referred for specialized evaluation, interprets available data and subjective information and uses professional knowledge and judgment to determine eligibility. This specialized assessment uses the Battelle Developmental Inventory II (BDI-II) and the Vineland Adaptive Behavior Scales to assess developmental and adaptive skills. The Transdisciplinary Play-Based Assessment-2 uses play to assess cognition, sensorimotor, communication, and social emotional skills. The Preschool Language Scale-5 (PLS-5) and the Clinical Evaluation of Language Fundamentals-4 (CELF-4) assesses both receptive and expressive language, and the family completes an extensive family and social history. The Autism Diagnostic Observation Schedule-2 (ADOS-2) is used to assess the number and severity of autism related signs and symptoms. Team members perform extensive observations of the child in the natural setting and classroom environment. Additional scales and assessments are given, depending upon individual needs. All assessments are recorded for further reference and a typical specialized assessment takes approximately 12 hours per student. The team also provides support during the evaluation programming conference by presenting and explaining all evaluation results.

After evaluations are completed and the evaluation programming conference has been held, the team assists cooperative teachers, general education teachers, and parents in setting up visual schedules and/or implementing strategies to be used in the classroom or at home.

Data for 2022-2023: Fifteen children were referred and assessed. Of the fifteen, eleven met the criteria for autism spectrum disorder. We currently have fourteen children on our caseload with autism spectrum disorder.

Goal:

To provide consultation, direct and support services to students who are blind or visually impaired, to their parents and to the school, center and related staff.

Program Description:

The Educational Vision Consultant/Orientation & Mobility Specialist at SWAEC served Arkansas's southwest, south-central, and southeast areas. The SWAEC Vision Consultant serves the counties of Polk, Scott, Pike, Montgomery, Columbia, Union, Ashley, Dallas, Clark, Hot Springs, Ouachita, Nevada, Lafayette, Miller, Hempstead, Howard, Sevier, and Little River. The ESVI consultant provided required assessments (Learning Media Assessment, Functional Vision Assessment, Orientation & Mobility Assessments, Assistive Technology Evaluations), consultations, direct Orientation and Mobility instruction, and recommendations for adaptations and modifications to meet the needs of students who are blind or visually impaired, ages 3 through 21, in an educational program. The ESVI Consultant also loans adaptive equipment to students in school districts and provides large print/braille textbooks through our Instructional Resource Center. In addition, professional development opportunities are offered to parents, teachers, and related staff.

Major Highlights:

During 2022-23, the ESVI consultant continued to be housed at SWAEC. This enables continued communication between member districts, other counties and co-ops served, SWAEC, and LEA staff serving special populations. The ESVI consultant provided training to area preschools, school districts, TVI's, and students who are visually impaired across Arkansas. In addition to training, the ESVI consultant offered direct service to the school districts, consulted as needed, attended TEAM meetings/IEP meetings, etc, provided required LMA/FVA/O&M assessments, and direct instruction in orientation and mobility. Also, the ESVI consultant provided schools/parents/TVI's with needed equipment/materials/resources for in-school and home instruction. The ESVI consultant worked closely with teachers of the visually impaired serving the schools. The ESVI consultant teamed with Easterseals to work with multi-handicapped students, with the CAYSI Project to work with deafblind students, and with the Division of Services for the Blind to work with transition students. Activities such as White Cane Day Celebration and Cane Quest Challenge are exciting activities that highlight cane skills and provide fun and competitive opportunities for students to demonstrate O&M skills taught. The ESVI consultant attended numerous training sessions to gain information and knowledge in skilled areas. Conferences/meetings attended that provided CEU credits included: Region 7 Meetings, Northwest TVI Meetings (by Zoom), Inclusive Practices, ACC Fall Convening, and LEA Academy. Conferences that provided required ACVREP credit hours needed for O&M certification: APH Annual Conference, AR-AER Conference, International Orientation and Mobility Online Symposium, Texas Deafblind Symposium, and Envision Conference West 2023. The ESVI consultant attended several staff meetings, consulted with ESVI consultants, and attended LEA meetings across the state in different co-op areas (some face-to-face, some Zoom). The ESVI consultant is serving on the Arkansas AER Board and attending a course with Perkins School for the Blind to further knowledge on working with students with cortical visual impairment.

Goal:

Serve as a liaison between ADE, Office of Gifted and Talented and Advanced Placement, district gifted/talented program coordinators, and parent and professional organizations. Provide technical assistance to meet the State Standards for Gifted and Talented Education and Advanced Placement. Promote gifted education through public awareness and advocacy.

Program Summary:

As the Gifted and Talented Specialist for SWAEC, my job revolves around making sure that the needs of the gifted learners in our districts are being met. This is only achievable by working with the fabulous GT educators across our nine districts and working hand-in-hand with DESE. On top of working with our Gifted educators who are responsible for meeting the needs of our gifted students in each district, it is also my responsibility to work with our regular education teachers to ensure that they are equipped with the tools necessary for helping our gifted students grow and blossom. Some of the services that I provide are: guiding GT Coordinators in the writing of the program application, pre-monitoring in preparation for monitoring of the program, and updating policies and procedures necessary for compliance. Hosted regular GT Advisory Council meetings to disseminate ADE updates, current trends and issues in gifted education, discuss practices and procedures for program compliance, share ideas and student activity events and dates, and keep abreast of the activities of the professional organizations for gifted and talented (Arkansans for Gifted and Talented Education and Arkansas Administrators of Gifted Education Association). Assisted member schools with various student activities such as Quiz Bowl, Vlog Competitions, Chess Tournaments, and even a Rubic's Cube Competition. I also provided professional development opportunities, including: Curriculum Differentiation, GT Scope and Sequence, Assessment for Identifying Gifted/Talented, whole group enrichment, how to better meet the needs of our twice exceptional students, classroom management for novice teachers, and creative ways to include Arkansas History into the curriculum with my Eerie Arkansas sessions.

Major Highlights of the Year:

My main goal this year was to try to present multiple opportunities for our gifted learners to share their talents in numerous GT centered events. Beginning in September, I challenged 3rd-12th grade gifted and talented students in our school districts to compete in our fifth annual Vlog Competition. Over 80 gifted and talented students across our districts participated in this competition. This gave our GT students an opportunity to debate issues, explore their talents in using video, research, and to use their creative talents utilizing technology. The Vlog Competition Award Ceremony was held on December 14th, where we invited all students who participated to join us via Zoom and discuss what they learned from the competition, and we awarded the winners. Also this year, we held Senior High, Junior High, 7th grade, 5th-6th grade, and 3rd -4th grade Quiz Bowls for the students of our nine school districts. Along with our regular Quiz Bowl opportunities, the students in several of our districts reached out to me and requested that we have Quiz Bowls with a superhero theme and a Star Wars theme. During the month of November, we held our first SWAEC/SCSC Superhero Quiz Bowl. We also held our SWAEC/SCSC Star Wars Quiz Bowl during the month of April. The kids absolutely loved these enrichment opportunities. On 9/23/22 through 10/3/2022 we were able to hold a face-to-face Chess Tournament for our Senior High GT students to show off their awesome chess skills. We were also able to hold our Junior High and Elementary Chess Tournaments face-to-face. One of the biggest events that we provided for our GT students this year was the Rubic's Cube Competition that we held on 12/5/2022. We held a team event and an individual event for the students to show off their cube solving skills. It was amazing! Lastly, we had a great interest from GT teachers across our nine districts, as well as from around the state, to hold an Eerie Arkansas session with GT students. We held thirteen virtual Eerie Arkansas sessions with GT students from all over the state (including our districts) where they were presented with information about the legend of The Fouke Monster. Their task, after doing some research on their own, was to come up with possible theories of what this strange phenomenon could be, and then, present their theories back to me. The information that they presented to me was absolutely awesome, and it turned out to be not only a great time for all that were attending, but an awesome learning experience for both the students and the educators.

Goal:

HIPPY is a family focused program that helps parents provide educational enrichment for their preschool children. The goal of HIPPY is to empower parents with the skills, tools, and confidence necessary to work with their children in the home. Parents will view themselves as their child's primary teacher and understand the critical role they play in their child's education.

Program Summary:

HIPPY (Home Instruction for Parents of Preschool Youngsters) is a home-based school readiness program for families of 3,4, and some 5-year-olds. HIPPY staff consists of a trained coordinator and home-based educators. Parents receive weekly curriculum, along with books and supplies for 30 weeks. Home-based educators deliver the curriculum to the home each week and role play the activities with the parent. The parent teaches the curriculum to their child. HIPPY serves families from all ethnic and racial groups. We have served 50 HIPPY families for the 2022-2023 program year. The staff administered the Ages and Stages Developmental Screening and the Ages and Stages Social/Emotional Screening to each child and the pre and post HIPPY involvement parent survey to each parent. The staff is involved in collecting and documenting information on each child for the purpose of entering data into the state data system, COPA (Child Outcomes Planning and Assessment.)

Major Highlights of the Year:

*Diamond Bank sponsored HIPPY family tickets to attend "Fairytale on Ice" at Hempstead Hall for exposure to performing arts. Families were also offered 5 other group meeting opportunities at various locations, including Hempstead County Library, Texarkana Library and Texarkana Parks and Rec.

* Preschool workbooks, backpacks, books, and craft materials provided for families for the summer to enrich school readiness learning

Program Summary:

The purpose of this grant is to provide professional development and on-site support to K-12 literacy teachers in the cooperative area. Professional development and on-site support is focused on the areas of curriculum, data analysis, science of reading and differentiated teacher support. It is the goal of the literacy specialist to enhance teacher awareness of current best practices and effective literacy instruction that follows the science of reading.

The literacy specialists work with ELA teams to increase their knowledge of High Quality Instructional Materials. Specialized trainings related to AR Edreports was provided to guide districts in making decisions about curriculum purchases.

Directed district support was provided in data analysis. Literacy specialist worked with districts to administer and analyze literacy screeners and diagnostic assessments. The data gathered was used to determine how to effectively group students for small group instruction. In addition to grouping, the data was used to develop appropriate tier 2 and 3 interventions.

Professional development was presented to help ensure that required teachers are developing a proficiency in the science of reading. The sessions include K-2 R.I.S.E. and 3-6 R.I.S.E., and all participants were provided on-site coaching support. Administrators were provided science of reading assessor training in the form of guided classroom walk throughs and debriefing sessions to discuss the evidence that was documented. Specialist also provided support to align science of reading components with current TESS evaluations.

On-site teacher support is customized to meet the needs of individual teachers and district goals. The support includes model lessons, lesson planning, corrective feedback and data analysis. In addition to classroom support, novice teachers were offered Praxis and Foundations of Reading study sessions.

In a coordinated effort with DESE, the specialists have provided directed support to 3 districts and coordinated support to 3 additional districts that directly related to school improvement goals. The goals were monitored monthly in virtual and face to face meetings with the DESE support team.

In conclusion, the literacy specialists provided the following student activities: Battle of the Books, Reading Fair and the County Spelling Bee. The activities promoted a culture of literacy and allowed students an opportunity to showcase their knowledge and skills.

The purpose of the mathematics grant is to provide professional development and onsite support to administrators, instructional facilitators and K-12 mathematics teachers in the cooperative area. The Math Specialist works to increase teacher content knowledge and implementation of research-based best practices through high quality professional development aligned with state and national standards in math. Partnering with the Arkansas Department of Education, SWAEC administers the Mathematics Program for grades K-12. Technical assistance is provided to schools using a variety of data, based on priorities within districts, to best meet individual needs for student success.

The Math Specialist currently supports teachers in 7 of 9 districts in AR Math QuEST (Quantitative Essentials for Students and Teachers). AR Math QuEST is a state-initiated professional development opportunity for exemplary teaching and learning based on NCTM's Effective Mathematics Teaching Practices and the Standards for Mathematical Practice. This two year professional training and support promotes best practices and the engagement of all students in reasoning and problem solving. The Math Specialist, along with a DESE State Specialist, supported 50 AR Math QuEST teachers in the co-op region and 10 Instructional Facilitators with 16 teachers fulfilling their two year commitment. The Math Specialist provided a minimum of 2 visits each semester, with most receiving 3 or more visits per semester. Means of support includes assistance with planning lessons, observations and reflective feedback. QuEST teachers received books based on their cohort year: Year 1 Cohort received NCTM's Taking Action and Cohort II received Smith and Stein's The Five Practices in Practice.

The Arkansas Division of Elementary and Secondary Education (DESE) was awarded a \$3 million grant from the Walton Family Foundation for Phase II funding of high-quality tier 1 mathematics curriculum (TIMC). Three SWAEC districts applied and were awarded funding for HQIM in 21-22. The Math Specialist has continued to support these districts in 22-23 by providing professional development, lesson planning and content support. Two districts received HQIM implementation support from TNTP (The New Teacher Project). The Math Specialist assisted teachers with lesson planning before TNTP walk-throughs and provided a reflection based on classroom visits.

The Math Specialist provided support to novice teachers through professional development, Praxis tutoring, lesson planning, classroom management, and content support. Relationships with novice teachers are prioritized and contact is accomplished through visits, email, texts and phone calls.

A task force was initiated through the AR Math Unit to begin discussions and professional development in the area of dyscalculia. The Math Specialist is a part of this task force. Areas of focus included establishing a state definition, screeners, methods of intervention and building teacher awareness for districts and families.

The Math Specialist supported 3 teachers through the TNTP Coaching Cycle. This cycle provided Illustrative Mathematics support with the intention of deepening understanding of the curriculum and how it can be implemented with fidelity. Conversations were based on individual need of support which included student engagement, implementation of the lesson, and facilitating critical thinking tasks through the Five Practices method.

Math centers were created and donated to an elementary school in support of their STEM night. Students earned tickets for prizes as they engaged in these centers. Students were also given a center to take home. Family involvement, math fluency, and the engagement of students in STEM was the emphasis.

Goal:

Objective 1: Quality of Mentoring Program/Day One Ready

SWAEC will help novice teachers to positively impact student achievement and enhance student growth with assistance through in-class coaching, informal mentoring, virtual meetings, and video observations. We will use differentiated support to provide a high quality program that meets the needs of area schools, prepares novices to be day one ready, and encourages the development of teaching expertise at all levels of the mentoring system as measured by 90% of teachers and principals rating the effectiveness of our program with three or higher on a scale of one to five and 100% of novices rating themselves in TESS domains 1-4 and reflecting on their growth.

Objective 2: Quality of Differentiation/Scaffolding of support for traditional, alternative routes, and licensure exceptions

SWAEC will promote the development of teaching expertise and improve teaching performance and well-being of novices through the use of, but not limited to, buddy teachers, SWAEC Mentoring Support Team members, Praxis and Foundations of Reading assessments support, SWAEC content specialists support, and outside consultants as needed. SWAEC will use school and individual novice plans to differentiate support for novice progression towards earning a career educator license as measured by:

*100% of year one novices making a timeline for certification, program completion, taking Praxis exam(s), and applying for their license

*at least 85% of year two novices attempting to pass their required Praxis exam(s), reflecting on their licensure plan and starting the application process for licensure

*100% of year three novices being licensed before the school year ends.

Objective 3: Data Points for Needs Assessments

SWAEC Mentoring will continue to use data and trends we gather from our teacher and administrator surveys to drive our program. Surveys will be passed out to 100% of novice teachers with anticipation of an 80% or better return. Data will be shared with area administrators, SWAEC content specialists, and the Office of Educator Effectiveness at DESE in the form of a Retention Report that goes out three times a year and a Licensure Report that goes out twice a year.

Program Summary:

The purpose of the Novice Teacher Mentoring Program is to support the professional growth of novice teachers in southwest Arkansas. Novice teachers are provided with three years of personalized support to meet individual needs through face-to-face meetings, on-site technical support, virtual coaching, on-line PLCs, etc.

This year the mentoring program provided support for 212 novices (100 year one, 60 year two, 35 year three, and 17 experienced out-of-state teachers). New novices received "The First-Year Teacher's Survival Guide," "The Classroom Management" book, and "The New Art and Science of Teaching" handbook. Dr. Sain joined SWAEC this year to provide our Year 2 novice teachers with Aligning Congruent Lesson Planning to Intentional Teaching. Our Year 3 teachers received support on being Year 3 Ready with an emphasis on TESS and Summative Evaluation from Janis Bremer.

Each week, novice teachers received a Monday Mentor's email with an inspirational message along with tips for a successful school year with topics that ranged from classroom management strategies to instruction and planning. The weekly message also contained information about current professional learning opportunities, webinars, and how to access support for Praxis and Foundations of Reading assessments. The R&R worked closely with SWAEC content specialists to help provide novice teachers Praxis and Foundations of Reading assessment support, content support, scheduling support, small group support, classroom management support, virtual tools support, etc.

Each month, teachers were given opportunities to meet virtually with the R&R concerning questions or ideas in which they needed assistance and any emotional support they may have needed. On-site visits were made to novice teachers for classroom management/procedures/routines support and when areas of need in content were identified, the R&R worked with SWAEC specialist to help provide support. Monthly topics were also addressed in various formats: email, virtual zooms, articles, etc. on ideas such as: Parent Teacher Conference advice, appropriate report comments, substitute folder ideas, etc.

This year the mentoring program continued with last year's new event titled "Novice Day of Learning." This monthly event allowed the teacher (or administrator) to customize a learning experience that was specific to the novice's individual learning needs. Classroom Management topics were included as a session choice every month. Sessions also focused on mental health, trauma, SOR strategies, and small group instruction. Special presentations were given by Jessica Saum, Arkansas 2022 Teacher of the year; Johnathan Crossley, Hope Superintendent; Connie Thomason, Arkansas Behavior Support Specialist; and Jessica Dearing, M.S., LPC. Those that attended these events appreciated the smaller atmosphere and gave feedback that the learning was very beneficial.

All teachers, including those on alternative certification pathways, were given opportunities of Praxis support and Foundations of Reading support through checkout materials, 240Tutoring, [study.com](https://www.study.com), & individualized tutoring sessions (upon request). This information was shared weekly through the Monday Mentor's Message, and tutoring sessions were posted on the novice teacher website and DESE website. This year we also offered a Praxis reimbursement program for novice teachers who passed their assessment on the first try. SWAEC also conducted two study groups, and for those who attended and met the study group requirements, the Praxis assessment fee was paid for with mentoring grant funds.

Information concerning novice teachers was given to building and district leaders in the SWAEC Recruitment and Retention Report throughout the school year. This information was also added to our novice teacher website.

Program Summary:

The Community Health Nurse Specialist is employed by Arkansas Department of Health and functions in a collaborative role with Southwest Arkansas Education Cooperative. Technical assistance is provided to the region's school district nurses and community coalitions through education and policy guidance and school health advocacy, with special focus on Best Practices for Nutrition, Physical Activity, Injury Prevention, and No-Tobacco. During the 2022-2023 school year, the CHNS continued to provide support services to local school districts and nurses.

CHNS activity related to the school setting includes advocating for the implementation of tobacco-free policies, best practices for tobacco prevention education, and best practices for promoting and implementing policies and programs for nutrition, physical activity, and emerging public health issues in the school-age child. The CHNS provides education for school nurses and wellness committees on health issues such as the consequences of tobacco use, injury prevention (intentional and unintentional), oral health, infant mortality, physical activity and nutrition. SWAEC CHNS is a CPR instructor and trains school staff, nurses, and community members in the American Heart Association's CPR/AED and First-Aid training programs. The CHNS assists schools in the implementation of laws that affect health and wellness in the school setting and offers assistance to schools on developing and maintaining wellness committees as required by Act 1220. The CHNS offers assistance with new tobacco laws, new or changing rules and regulations (kindergarten physical, immunizations, etc.), and trains school nurses on all mandatory screening (hearing, vision, BMI, & scoliosis).

Under the ADH, CHNSs are able to offer free NCPD (Nursing Continuing Professional Development) on certain workshops to school nurses to maintain their professional licenses. CHNSs survey school nurses and school staff to offer training and workshops that meet the needs of school health.

CHNSs offer programs and presentations to the students on school campuses in an assembly or classroom setting and are available as presenters and can assist in finding presenters to meet the schools' needs. The SWAEC CHNS has planned and will facilitate, and /or will present at several workshops this summer for school staff, wellness committees, and nurses, both at SWAEC and at other co-ops in the SW Region.

Southwest CHNSs (Dawson, DeQueen/Mena, South Central, and Southwest Co-op CHNSs) work closely together to meet the needs of Southwest Arkansas. CHNSs and CHPSs provide regional training to provide a level of consistency throughout the SW Region and cross borders to assist in other school districts to meet the needs of the school.

Activities of the CHNS related to the community setting include health fairs to promote health and wellness to the communities. Health fairs may also be on the school campus, in the community, or at a local job site. Health presentations are offered to community clubs (Lions Club, Rotary Club, minority clubs, etc.), worksites, and anyone else who requests these presentations. Here is a list of a few examples of presentations the SWAEC CHNS and CHPS can present in the community: CPR, First Aid, Summer Safety, Colorectal Education, Tobacco Education, STD/Reproductive Health, Stop the Bleed, etc. CHNSs attend several statewide meetings and trainings to stay abreast of school health topics and issues and collaborate at the state, regional, and local levels to provide continuity between the Arkansas Department of Education and the Arkansas Department of Health for the health of our students. CHNSs also work closely with Arkansas Children's Hospital, local hospitals, Arkansas Center for Health Improvement (ACHI), State Injury Prevention, Arkansas Cancer Association, Arkansas Prevention Resource, and State and local police. The SWAEC CHNS is a member of four county health coalitions. She attended state CHNS/CHPS meetings and other regional and local meetings. By partnering with local health unit administrators, she strives to meet the health needs of the community.

The major highlights of the 2022/2023 school year include providing updated mandatory screenings for Vision/Hearing/Scoliosis/ Obesity Prevention (BMI). All received a certificate of completion.

Goal:

Our goal, through these programs, is to provide quality professional development training, primarily in the 13 critical areas, as outlined by the Arkansas Department of Education. The focus is to assist area schools in meeting the needs of their individual School Improvement Plans and to improve student achievement. These training sessions are funded through our Professional Development Consortium (PDC), in which seven of our nine districts participate. Participating districts contribute \$100 per certified staff member to the consortium. This funding helps support training sessions that cover a variety of related topics for which teachers and/or administrators have expressed a need. These funds are also instrumental in supporting several state initiatives, such as RISE, Science GPS and Teacher Evaluation. Districts not participating pay a per session fee.

Program Summary:

The Teacher Center Coordinator has a primary responsibility for planning and carrying out the Professional Development Program for member districts. The professional development programs are, in part, identified by the Teacher Center Committee as a priority among member districts. A wide variety of workshops and seminars are provided for teachers and administrators throughout the year, utilizing the expertise of regional, state and national consultants to train school personnel to help them develop both professionally and personally. Collaboration with the ADE and other agencies exists to provide professional development for specific groups such as: Special Education Teachers, Limited English Proficiency Teachers, Federal Coordinators, Gifted and Talented Teachers, Food Services, and Migrant Educators. Technology is supported through a variety of training sessions here at the Co-op and at the school sites.

Major Highlights of the Year:

Novice Teacher Mentoring training, School Board Member Training, RISE, and Math Quest. A separate PD activities report is included.

Summary

The purpose of this grant is to provide professional development and on site support to K - 12 teachers of science/STEM subjects in the SWAEC area. The scope of impact includes a variety of state, national, and local level services.

School Support

On site support included 80 school visits/contacts, in both individual and group settings, ranging from PLC support, direct teacher support, and admin support with HQIM, etc. Occasionally, the specialist assisted with some peripheral support, e.g., provided specimens/materials for a particular lesson or unit, judged a local science fair, and assisted in the procurement of grants for state park field trips. The specialist supported the planning and set up of a parent STEM night at Lafayette County Elementary School. The specialist participated in two TNTP coaching cycles with two teachers in SWAEC schools. The specialist regularly attended the after-school K - 6 PLC meetings at Lafayette County Elementary School and provided related support when requested.

Professional Development

The specialist presented, developed, or supported 22 science professional development sessions from July 1, 2022 to June 30, 2023. This includes DESE provided sessions, specialist developed sessions, facilitated guest presenter sessions, a two day STEAM conference, and the #TeachSouthwest mini-conference. Sessions were held on and off the SWAEC campus. The specialist provided professional development within the ArPEP system, specifically the Lesson Planning/HQIM session and provided a session for Novice Day of Learning. The specialist presented a STEM session on Scientific Modeling at the ADE Summit. The specialist created a series of professional development sessions, Fun!omenal Arkansas, which leverage geo-relevant phenomena and resources aligned with the principles of Place Based Learning and community engagement. The specialist often coordinates with a STEM Specialist at DESC to provide rural educators an opportunity to collaborate with other educators.

At the state level, the specialist collaborated in writing the high school Biology Integrated content professional development that is available statewide to model the attributes of three dimensional, phenomenon driven, storyline framework biology instruction that is aligned with the Arkansas K-12 Science standards and the student centered vision of the NGSS.

STEM Model School Designation

The specialist supported the new Arkansas STEM Model School Designation certification process by supporting Arkansas High School Freshman Academy, a SWAEC school.

Project Lead the Way Grants

The specialist assisted in the acquisition of PLTW grants for two SWAEC campuses, Blevins High School, and Yerger Junior High School.

AIIM

Aligning with the mission of the Arkansas Initiative for Instructional Materials, the specialist continued as a senior EdReports Klawe fellow, advocating for the Arkansas' AIIM and EdReports Materials Matter message. The specialist increased awareness of the processes for the selection and implementation of HQIM in Science and provided guidance through presentation and on site consultation.

ArDSCE

The specialist served as a member of the Arkansas Data Science and Computing Ecosystem and is a member of the Southwest Arkansas Team. The Arkansas Data Science and Computing Ecosystem (ArDSCE) is a statewide community of practice from education, government, business, industry, and nonprofits committed to data science and computing economic growth and workforce development through data-informed education and training pathways for Arkansans.

STEM Community Supports, Collaborations, and Outreach

The specialist served as a board member of the ISEF Regeneration Ouachita Mountains Regional Science and Engineering Fair (HS) and the ISEF Broadcom Masters Ouachita Mountains Regional Science and Engineering Fair (MS). Through the development of the Funlomenal Arkansas series of professional development, partnerships with the following informal/formal educational entities were formed: Old Washington Historic State Park, Southwest Arkansas Arts Council, Arkansas Game and Fish Commission, Arkansas Environmental Education Association, University of Arkansas STEM Education, the Museum of Discovery, the USDA County Extension Service, the Robotics Education and Competition Foundation, and the Arkansas Geological Society. As ancillary support activities, the specialist assisted with the SWAEC Battle of the Books, Book Fair, Quiz Bowl, and CTE's Girl Power to the Max competition.

Additional Information

The specialist attended the ACESSE Support for Rural Educators Institute and is engaged in developing professional development and support for rural science educators who are singletons and teaching multiple preps. The institute is composed of Chief State Science Officers from Arkansas, Oklahoma, Iowa, Missouri, and Kansas and is supported by the University of Washington ACESSE group.

The specialist is on the National Science Teaching Association's Rural Educators Advisory board, which advises the NSTA board on how the NSTA can better reach and support rural science educators across the nation.

Goal:

The purpose of the Teacher Center is to provide services to our schools in three basic areas: staff development, curriculum development assistance, and educational materials. We meet those goals in a number of ways in both the Teacher Center and other areas of the Co-op. The Teacher Center Advisory Committee works closely with the Teacher Center staff and the Co-op Board of Directors. This open channel of communication assures that we continue to understand and meet the needs of educators we serve.

Program Summary:

The SWAEC Teacher Center provides a place for teachers, paraprofessionals, and administrators of all member districts to work on instructional materials, develop curriculum, and obtain instructional and media materials to meet the needs of their classroom. The instructional materials have been developed to coordinate with the Arkansas Standards. Instructional resources are available for teachers to use in the classroom. The primary focus of the instructional material is reading, math and language arts; however, we do have materials available for other subject areas. Technical assistance is available for educators, from laminating and supplies to curriculum designed to meet a specific need. One of the most popular services of the Teacher Center is the Ellison lettering machines and the numerous dies available for use. During the school year, the SWAEC makes Ellison cuts available to schools through six Ellison kits that travel to different buildings. Additionally, the Teacher Center provides teachers and administrators the use of a banner/poster maker, a binding machine, two laminators and copiers. Teachers use the Teacher Center on a regular basis for help and assistance through personal visits, phone calls, and school visits through the delivery system. The Center serves preschools and daycares, in addition to our member school districts. There are approximately 35 preschools and daycares that use the SWAEC Teacher Center services on a regular basis. Students from UAHT, Texas A&M- Texarkana and Henderson regularly use the SWAEC Teacher Center services. Private schools in the SWAEC service area also use the Teacher Center.

Program Summary:

The SWAEC Technology Coordinator supports the co-op staff by making sure they have all of their technology needs met, and provides training for the staff on how to use the technology appropriately. He also provides frequent trainings for staff on data security best practices, internet safety, and any other cyber related best practices promoted by DIS and DESE.

The SWAEC Technology Coordinator provides support for member district's teachers, students, and their technology staff with anything from technology requests, helping determine hardware needs, helping determine any software needs, skills trainings, professional development and helping foster communication with vendors. He also makes sure that school districts, their IT staff, and administration have the most up-to-date information concerning technology and cyber awareness. This information is coordinated with DESE, DIS, and the P-12 Cyber Incident Team.

The SWAEC Technology Coordinator is one of the state escWorks specialists and provides support to all Arkansas school districts for questions and ticket requests with escWorks.

Special Projects

SPECIAL PROJECTS AND PROGRAMS

Detailed below are special projects or programs in which state funding provided services regionally or statewide, giving this cooperative an opportunity to participate.

Program Name: Communities of Practice

Description:

Building Communities of Practice (CoP) is focused around Identifying Learning Loss and Accelerating Learning using High-Quality Instructional Materials (HQIM). DESE, in partnership with a national partner, will bring together groups of Arkansas system leaders (district and school teams). The Community of Practice will explore the leadership practices necessary to implement math and/or literacy instruction and learning supports that meet the moment, while staying focused on long-term recovery and acceleration goals.

The CoP includes a series of sessions, such as research and evidence-based strategies to address and plan for the acceleration of learning using HQIM.

Grantee will select vendors from those approved by Rivet Education to contract with for professional services to engage in content coaching, with emphasis on HQIM.

Program Name: Professional Learning Communities: Boardroom to Classroom

In support of the DESE's PLC Initiative, co-ops have been participating in the Boardroom to Classroom trainings monthly with Janel Keating from Solution Tree. As part of this process, Janel Keating guided educators in developing successful districtwide professional learning communities to ensure high levels of learning for every student. High-performing districts develop when collaborative teams at every level align their concepts, practices, and vocabulary. Aligning this work is a top-down, bottom-up cyclical process, starting with the district level and ending with collaborative teacher teams. This session provided district and school leaders with the tools and strategies needed to create a districtwide culture of continuous improvement. Co-ops are an integral part of this work and have been supporting districts involved in these sessions through Specialist support and working with administrators who are implementing PLC processes.

Program Name: Act 1082 Support

Act 1082 is designed to provide certain levels of support to public school districts based on reading scores. Level 3 schools receive "coordinated support," provided for those districts in which forty percent or more of the district's students score "in need of support" on the state's prior year summative assessment for reading. Level 4 schools receive "directed support" due to fifty percent or more of its students scoring "in need of support" on the summative assessment.

The goals of this support include helping schools deploy more powerful strategies, use resources more productively, and analyze the curriculum that is used. To that end, both Level 3 and Level 4 schools meet periodically with the Public School Program Advisor from the DESE and the co-op team, either virtually or in-person. Level 3 schools are required to meet once every nine weeks and Level 4 schools meet monthly. During these meetings, a spreadsheet is reviewed that includes the topics: Literacy Curriculum, Assessments, Science of Reading, Dyslexia, and Writing Revolution. This spreadsheet is a living document that all stakeholders can update as actions are taken in support of any of the given areas.

Co-op literacy specialists also provide regular support throughout the year to these schools. This support can be in the form of model teaching, professional development for teachers and/or paraprofessionals, classroom walkthroughs with principal, or anything that is identified by the school or in the coordinated meetings. The professional development opportunities are designed to provide personalized support to ensure that all teachers acquire the instructional expertise needed to educate all students and improve reading skills.

Program Name: Marvell-Elaine Instructional Support

The Marvell-Elaine School District was placed on Level 5 in November 2022. Subsequently, their waiver for student enrollment size was denied in December 2022. With these two events, a report of a high percentage of teachers not being licensed in their teaching assignment, and a realization that the district was in need of high quality instruction for secondary students, the Office of Coordinated Support and Service requested for cooperatives to provide direct instruction in the English Language Arts, Mathematics, Science, and Social Studies classrooms at Marvell-Elaine High School. The subject-area leads for the project were: Terri Guy, OCSS (ELA); John Hoy, OCSS (Math), Patrick Quattlebaum, Great Rivers (Science), Kelsey Riley, Great Rivers (Social Studies). The goal of this project was to provide high quality instruction to the seventh through twelfth grade students during the third and fourth nine weeks of the 2022-2023 school year.

SWAEC was able to send a high school literacy specialist to teach literacy, and our GT specialist taught social studies for a week.

ESC Evaluation

Per Ark. Code Ann. § 6-13-1020 and Rules Governing Education Service Cooperatives Sections 21.00 and 22.00, all active Education Service Cooperatives must be evaluated at least once every five years and include the results in the annual report submitted to the Department of Education. The evaluation schedule is determined by the Commissioner of Education and conducted by an evaluation committee of no more than nine people. The committee is made up of local stakeholders, educators, representatives for higher education, and parents.

The evaluation process includes an investigation of user satisfaction, service adequacy, extent of local financial support, staff qualifications, and performance and administration effectiveness. This information is shared with the committee via a cooperative [NARRATIVE SUMMARY](#) and [EVALUATION RUBRIC & LINKED DOCUMENTS](#). The evaluation committee reviews the evidence for each component, as well as conducts interviews with a variety of stakeholder groups: administrators, cooperative employees, regional educators, and special focus groups determined by the cooperatives. The interviews allow regional districts the opportunity to express their satisfaction and concerns regarding the manner in which the cooperative is operating and fulfilling the needs of the schools.

At the conclusion of the on-site visit by the evaluation committee, the committee indicates the cooperative's levels of success in each category using the criteria outlined in the rubric found in Appendix 2 in the Rules document. Each section of the rubric is scaled from 1 ("in need of immediate support") to 5 ("excellence"), and the cooperative is assigned an overall rating of 1 to 5. The final report of the evaluation is presented to the cooperative, region districts, and the State Board of Education.

Our cooperative received an overall rating of a 4 Exceeding Standards. Our FINAL EVALUATION REPORT was presented to the State Board of Education and accepted by the board on June 8, 2023.

Program Name: Teacher Excellence Support System (TESS)

Competitive Grant No

Goals and Description: The Framework for Teaching by Charlotte Danielson provides the foundation for the Arkansas Teacher Excellence and Support System (TESS). Southwest Arkansas Education Cooperative held the three hours Law and Process training(s). The Arkansas Department of Education provided training at each co-op for districts that opted in for premium services. Southwest Arkansas Education Cooperative scheduled additional sessions to extend the learning and to support administrators and teachers as they continue to implement TESS as the teacher evaluation system.

Southwest Arkansas Education Cooperative Technology Coordinator and staff have provided support to district testing and technology personnel as preparations were made for the initial implementation of ACT Aspire in the spring of 2016. Support included onsite visits within districts to aid in preparing technology infrastructure, providing multiple training opportunities for ACT Aspire updates, and hosting ACT Aspire workdays to help with data entry and test scheduling. SWAEC partnered with SCSC & DMESC to host *Girl Power to the MAX!* SWAEC event and regional event for girls to compete using CNC Plasma Cutting and CNC Lasering machines.
